1 Name

This determination is the *Public Service (Subsection 24(1)—Australian Electoral Commission Non-SES Employees) Determination 2021.*

2 Commencement

This determination commences on the date it is signed.

3 Authority

This determination is made under subsection 24(1) of the *Public Service Act* 1999.

4 Application

This determination applies to non-SES employees employed in the Australian Electoral Commission under the *Public Service Act 1999* who are covered by the Australian Electoral Commission Enterprise Agreement.

5 Definitions

In this determination:

Australian Electoral Commission Enterprise Agreement means the enterprise agreement approved by the Fair Work Commission on 29 November 2016 and known as the Australian Electoral Commission Enterprise Agreement 2016 - 2019.

Electoral Commissioner means the Electoral Commissioner of the Australian Electoral Commission.

Wage Price Index (WPI) – Private Sector Adjustment means the applicable WPI – Private Sector percentage adjustment under the Public Sector Workplace Relations Policy 2020.

6 Purpose

The purpose of this determination is to adjust employees' salaries and allowances for which they are eligible under the terms of the Australian Electoral Commission Enterprise Agreement.

7 Period of operation

This determination is in force for the period:

- (a) beginning at the start of the day this determination commences; and
- (b) ending at the earlier of the following:
 - (i) the start of the day that an enterprise agreement made in accordance with the Fair Work Act 2009 that covers the employees and replaces

- the Australian Electoral Commission Enterprise Agreement commences operation;
- (ii) the start of the day that another determination under subsection 24(1) of the *Public Service Act 1999* that applies to the employees and revokes this determination comes into force.

8 First annual adjustment of salary and allowances

- (1) Employees' salaries are adjusted by 1.9%, with effect from 1 December 2021.
 - Note: The percentage adjustment in salary is equal to the most recent percentage change in the annual June Private Sector WPI as advised by the Australian Public Service Commission.
- (2) Each adjustment is to be calculated based on the salary immediately before the adjustment under subsection (1).
- (3) Health and Safety Representative Allowance, First Aid Allowance and Multiple Divisional Site Management Payment Allowance are adjusted by the same percentage as their salaries, with effect from 1 December 2021.
- (4) Each adjustment of an allowance is to be calculated based on the allowance immediately before the adjustment under subsection (3).
- (5) Schedule 1 has effect.

9 Second annual adjustment of salary and allowances

- (1) Employees' salaries are adjusted by X% or 2.3%, whichever is the lower, with effect from 1 December 2022.
 - Note: The applicable percentage adjustment in salary will be inserted in Year 2 in line with the most recently published annual June Private Sector WPI% as advised by the Australian Public Service Commission.
- (2) Each adjustment is to be calculated based on the salary immediately before the adjustment under subsection (1).
- (3) Health and Safety Representative Allowance, First Aid Allowance and Multiple Divisional Site Management Payment are to be adjusted by the same percentage as the salaries, with effect from 1 December 2022.
- (4) Each adjustment of an allowance is to be calculated based on the allowance immediately before the adjustment under subsection (3).
- (5) Schedule 2 is to be changed to reflect the adjustments.

1 Salary

From 1 December 2021, salary for an employee covered by column 1 of an item of the following table at a pay point described in column 2 of the item is payable at the rate for that pay point (the *new rate*) described in column 3 of the table. This is an adjustment of 1.9% under subsection 8(1) of this determination.
