## **1.1 DETERMINATION MADE BY THE AUGMENTED ELECTORAL COMMISSION FOR QUEENSLAND**

Pursuant to section 73 of the *Commonwealth Electoral Act 1918*, the augmented Electoral Commission for Queensland hereby determines that the names and boundaries of the electoral divisions into which Queensland is to be distributed are as shown on the maps certified by the members of the augmented Electoral Commission for Queensland and lodged in file number 09/2901 at the National Office of the Australian Electoral Commission in Canberra. These maps are numbered in the following sequence:

The augmented Electoral Commission for Queensland reached this determination on the basis that it determined the names and boundaries of the electoral divisions in Queensland should be as proposed by the Redistribution Committee for Queensland in its report published on 24 July 2009, subject to the following changes:

- (i) The new Division of Wright shall be altered on its north eastern boundary, with Boronia Heights and part of Greenbank located in the Division of Forde, and Jimboomba, Logan Village, Stockleigh and Yarrabilba located in the Division of Wright;

- (ii) Kuranda, bounded by the Clohesy and Barron Rivers and Armstrong, Mona Mona and Black Mountain Roads, shall be located in the Division of Leichhardt. The boundary between the Division of Kennedy and the Division of Leichhardt will then, generally, follow the Tablelands Regional Council boundary, McLeod River and the existing divisional boundary on the Mitchell River;
- (iii) Montville shall be located in the Division of Fisher and more of Palmwoods shall be transferred from the Division of Fisher to the Division of Fairfax;
- (iv) That part of the former Pine Rivers Shire Council (the Dayboro/Kurwongbah areas) proposed to be transferred to the Division of Longman shall be located in the Division of Dickson and more of Kallangur shall be located in the Division of Longman;
- (v) Brighton, Deagon, Sandgate and Shorncliffe shall be located in the Division of Lilley;
- (vi) Aspley (part), Bridgeman Downs (part), Carseldine and Fitzgibbon shall be located in the Division of Petrie;
- (vii) That part of Toowong proposed to be transferred to the Division of Brisbane shall be located in the Division of Ryan;
- (viii) All of Underwood shall be located in the Division of Rankin;
- (ix) More of Oxley, south of Ipswich Road, shall be transferred to the Division of Moreton from the Division of Oxley;
- (x) That part of the Dalby Regional Council (now Western Downs Regional Council) in the Division of Flynn shall be transferred to the Division of Maranoa;
- (xi) One Census Collection District (3050114) in the Burdekin Shire Council shall be transferred from the Division of Dawson to the Division of Kennedy; and
- (xii) Part of the boundary between the Division of Fairfax and the Division of Fisher shall be altered to follow the boundary between Mountain Creek and Parrearra and Sippy Downs.

## **1.2 REASONS FOR THE DETERMINATION MADE BY THE AUGMENTED ELECTORAL COMMISSION FOR QUEENSLAND**

### **Executive summary**

1. As required by a determination under section 48(1) of the *Commonwealth Electoral Act 1918*, (the Electoral Act), the number of electoral divisions in Queensland will increase from 29 to 30. On 24 July 2009 the Redistribution Committee, after consideration of the criteria set out in the Electoral Act and the public suggestions and comments, proposed an appropriate location and name for the new division, and changes to boundaries of existing divisions throughout the state.
2. The Redistribution Committee noted that enrolment growth was projected to be highest in south-east Queensland. While some major regional centres were projected to experience growth, rural areas were trending below the average growth. This reflects the pattern of population growth throughout the state. In this context, the new division was proposed to be located in south-east Queensland, in an area south and west of Brisbane, and be named Wright.
3. Following the release of the Redistribution Committee's proposal, the augmented Electoral Commission received 555 objections and 19 comments on objections, and conducted a public inquiry. Approximately 450 of the objections received were regarding the transfer of Annandale and Wulguru from Herbert to Dawson. Submissions were also received regarding a number of other issues, including the name of the new division. The augmented Electoral Commission gave careful consideration to all submissions and ultimately adopted the Redistribution Committee's proposal, with some changes.
4. The augmented Electoral Commission acceded to a number of objections, where the enrolment tolerances could be met, to better reflect community of interests, means of communication and travel, physical features and area of divisions, and existing boundaries. A number of objections were not upheld because they failed to meet the criterion relating to projected enrolment numbers. In cases where compensatory adjustments to the enrolment numbers could have been made elsewhere, the augmented Electoral Commission concluded that other criteria in the Electoral Act, such as community of interests, were more appropriately met by the Redistribution Committee's proposal.
5. The substance of the deliberations and conclusions of the augmented Electoral Commission concerning the objections, matters discussed at the public inquiry and the Redistribution Committee's proposal, follows in this report. In summary, the augmented Electoral Commission decided to:
  - accept the Redistribution Committee's proposal to name the new division Wright;
  - accept the boundaries proposed by the Redistribution Committee for the divisions of Blair, Bonner, Bowman, Capricornia, Fadden, Griffith, Groom, Herbert, Hinkler, McPherson, Moncrieff and Wide Bay; and



- make minor changes to the boundaries proposed by the Redistribution Committee for the divisions of Brisbane, Dawson, Dickson, Fairfax, Fisher, Flynn, Forde, Kennedy, Leichhardt, Lilley, Longman, Maranoa, Moreton, Oxley, Petrie, Rankin, Ryan and Wright.

### **Direction for a redistribution of Queensland electoral divisions**

6. On 17 February 2009, the Electoral Commissioner made a determination of state and territory representation entitlements under section 48(1) of the Electoral Act. Under the determination, Queensland is entitled to 30 members of the House of Representatives, one more than its previous entitlement.
7. Section 59(2) of the Electoral Act provides that a redistribution shall be directed whenever a determination under section 48(1) results in an alteration to the number of members of the House of Representatives to be chosen in a state. Consequently, on 19 February 2009, the Australian Electoral Commission (the Electoral Commission) directed by notice published in the Commonwealth Government Gazette (the Gazette) that a redistribution was to commence in Queensland.
8. At the end of 19 February 2009, the date determined by the Electoral Commission for the redistribution to begin, the number of electors enrolled in Queensland was 2 650 299.
9. Redistribution statistics which show the detailed electoral enrolment figures as at 19 February 2009 were made available on the Australian Electoral Commission (AEC) website. In addition, copies were available upon request at the Queensland State Office of the AEC in Brisbane. The statistics were given at the following levels:
  - Census Collection District (CCD)
  - Statistical Local Area (SLA)
  - Electoral Division
  - State.

### **Quota**

10. Under section 65 of the Electoral Act, the Electoral Commissioner determined that the quota of electors for Queensland was 88 343 (2 650 299 divided by 30 members). The permitted range of 10% below and above the quota was 79 509 to 97 177 respectively as at 19 February 2009 (Table 1). The Electoral Act does not permit any greater variation from the quota to be provided for in a redistribution.

## **Appointment of the Redistribution Committee for Queensland**

11. In accordance with section 60 of the Electoral Act, the Electoral Commission appointed the Redistribution Committee for Queensland on 21 April 2009. The Redistribution Committee comprised the following members:

## **Redistribution Committee's proposed redistribution**

12. All preconditions having been met, the Redistribution Committee made a proposed redistribution of Queensland under section 66 of the Electoral Act, stating its reasons in writing; caused the notice required by section 68(1)(c) of the Electoral Act to be published in the Gazette on 24 July 2009; and took the other steps required by section 68.

## **Projected enrolment**

13. In making its proposed redistribution, the Redistribution Committee was required by section 66(3) of the Electoral Act, as far as practicable, to endeavour to ensure that, if a redistribution proceeded in accordance with its proposal, the number of electors enrolled in each electoral division in Queensland would not, at the projection time determined under section 63A, be less than 96.5% or more than 103.5% of the average divisional enrolment of the state at that time. Correspondingly, the augmented Electoral Commission is required by section 73(4), in making its determination, as far as practicable, to endeavour to ensure that the number of electors enrolled in each electoral division in Queensland will not, at the projection time determined under section 63A, fall outside the same parameters.
14. The Electoral Commission was of the opinion that, based on the trend of population change as estimated by the Australian Bureau of Statistics (ABS), a further redistribution of Queensland may be required sooner than seven years after the starting time for the projection. Therefore, pursuant to section 63A, the Electoral Commission determined the projection time for Queensland to be 9 July 2012, which is half way between the starting time for the projection (15 December 2009) and the time when in the opinion of the Electoral Commission a further redistribution may be required (February 2015).

15. The projected total enrolment for Queensland on 9 July 2012 is 2 916 951, resulting in an average projected enrolment of 97 232. Thus the permissible variance, being within the range of plus or minus 3.5% of the average projected enrolment figure, is between 100 635 and 93 829 (Table 1).

### **Objections and comments on objections**

16. A total of 555 objections and 19 comments on objections were received. These are listed at Appendices B and C of this report, and are provided in full on the enclosed CD. The objections and comments on objections were also made available on the AEC website.

### **Augmented Electoral Commission**

17. By section 70(1) of the Electoral Act, there is established for the purposes of a redistribution an augmented Electoral Commission for the relevant state or territory. By virtue of section 70(2) the members of the augmented Electoral Commission for Queensland (augmented Electoral Commission) are the Chairperson of the Electoral Commission (Hon Peter Heerey QC); the member of the Electoral Commission other than the Electoral Commissioner and the Chairperson (Mr Brian Pink, Australian Statistician); and the occupants of the positions previously mentioned who constituted the Redistribution Committee.

### **Public inquiry**

18. The augmented Electoral Commission held a public inquiry into the objections with hearings held in Cairns and Townsville on 29 September 2009, and in Brisbane on 30 September 2009. Arguments were presented on these occasions by five persons in Cairns, nine persons in Townsville, and eight persons in Brisbane (one of whom also made representations on behalf of four other persons), and have been carefully considered by the augmented Electoral Commission, together with all the objections and comments. Persons who appeared at the public inquiry are listed at Appendices D, E and F.
19. The transcripts of the public inquiry are provided on the enclosed CD.

### **The statutory mandate of the augmented Electoral Commission**

20. By section 73 of the Electoral Act, it is the augmented Electoral Commission for Queensland which must determine, by notice published in the Gazette, the names and boundaries of the electoral divisions into which Queensland is to be distributed. That

task must be performed in accordance with the requirements of section 73(4) and (4A), which provide:

*'(4) In making the determination, the augmented Electoral Commission:*

*(a) shall, as far as practicable, endeavour to ensure that the number of electors enrolled in each Electoral Division in the State or Territory will not, at the projection time determined under section 63A, be less than 96.5% or more than 103.5% of the average divisional enrolment of that State or Territory at that time; and*

*(b) subject to paragraph (a), shall give due consideration, in relation to each Electoral Division, to:*

*(i) community of interests within the Electoral Division, including economic, social and regional interests;*

*(ii) means of communication and travel within the Electoral Division;*

*(iv) the physical features and area of the Electoral Division; and*

*(v) the boundaries of existing Divisions in the State or Territory;*

*and subject thereto the quota of electors for the State or Territory shall be the basis for the redistribution, and the augmented Electoral Commission may adopt a margin of allowance, to be used whenever necessary, but in no case shall the quota be departed from to a greater extent than one-tenth more or one-tenth less.*

*(4A) When applying subsection (4), the augmented Electoral Commission must treat the matter in subparagraph (4)(b)(v) as subordinate to the matters in subparagraphs (4)(b)(i), (ii) and (iv).'*

21. These statutory requirements are expressed in an hierarchical order which puts, 'as far as practicable', the 'endeavour to ensure' a division will fall within the projected enrolment range first; the considerations of 'community of interests within [a division] including economic, social and regional interests', 'means of communication and travel within [a division]', and 'the physical features and area of [a division]' second; and 'the boundaries of existing divisions' third – while stating that, subject to these matters, 'the quota of electors for the state ... shall be the basis for the proposed redistribution' and that 'the augmented Electoral Commission may adopt a margin of allowance' not departing from the quota further than by one-tenth more or less.

22. The purpose of paragraph 4(a) is suggested by its history. The *Commonwealth Electoral Legislation Amendment Act 1983* stipulated that boundaries were to be drawn, as far as practicable, to achieve equal numbers of electors in each of a state's electorates three-and-a-half years after a redistribution. By 1984 'it was observed that the three-and-a-half year rule had in some areas forced the adoption, on purely numerical

grounds, of boundaries which took little account of perceived community of interest'.<sup>1</sup> Therefore, in 1987, the rule was relaxed to permit a measure of tolerance to plus or minus two percent from average projected enrolment. Subsequently the Joint Standing Committee on Electoral Matters concluded that:

‘the numerical criteria do not allow “due consideration”, in the words of the Act, to be given to the qualitative factors. Rather, the political parties and others attempting to frame electoral boundaries essentially find themselves engaged in a mathematical modelling exercise. In order to relax the enrolment requirements to that extent necessary to allow a realistic degree of flexibility the Committee recommends ... that subsections 66(3)(a) and 73(4)(a) of the Electoral Act be amended, so as to extend the variation from average divisional enrolment allowed three-and-half years after a redistribution from two to 3.5 percent.’<sup>2</sup>

23. The Joint Standing Committee also, in the same report, refers to its recommended amendment as one that ‘would maintain substantial restrictions on malapportionment [and] would allow other legitimate policy objectives to be more effectively met’.
24. Paragraph 4(a) follows this recommendation. The terms of the recommendation, and the discussion which preceded it, make clear the purpose of paragraph 4(a), as it now stands, and how it was intended to interact with the other criteria set out in the sub-paragraphs of paragraph 4(b), to which ‘due consideration’ must be given. The augmented Electoral Commission has made its redistribution on this basis.

### **Consideration of the Redistribution Committee’s proposal and of objections, comments and arguments presented at the inquiry in hearings held in Cairns, Townsville and Brisbane**

25. The augmented Electoral Commission noted that while 555 objections and 19 comments on objections had been received, these related primarily to the location of boundaries involving a number of specific areas within the state. These specific areas are discussed below when individual divisional boundaries are addressed. Of the total number of objections, some 38 related to the name of the new division, of which 31 put forward an alternative name.
26. The augmented Electoral Commission acknowledged the population growth and resulting increase in enrolment in various areas across the state. A continuing trend of growth is evident in a number of major regional centres along the coast, with higher growth occurring in areas of the south-east corner of the state.
27. Based on these growth patterns, the augmented Electoral Commission accepted the Redistribution Committee’s proposal that the new division should be located in:
  - the south-east of the state; and

- an area stretching from the Gold Coast hinterland, through Beaudesert and Boonah (Scenic Rim Regional Council), to Laidley and Gatton (Lockyer Valley Regional Council).

### ***The name of the new division***

28. The new division is to be named 'Wright'. Judith Wright (1915-2000) made a significant contribution to Australia as a social and environmental activist, and poet. She was a resident of Queensland for over 30 years, 20 of which were spent at Mt Tamborine, which is located within the boundaries of the new division.
29. The augmented Electoral Commission noted the Redistribution Committee's observation that Ms Wright 'was the founding President of the Wildlife Preservation Society of Queensland and was involved in measures to assist in saving the Great Barrier Reef, later helping to preserve large areas of rainforest and coastal lands. In the 1980s Ms Wright was a founding member of the Aboriginal Treaty Committee, which was the culmination of her work as a long-term champion of Aboriginal people and culture'.<sup>3</sup>
30. The augmented Electoral Commission received a number of submissions proposing the name 'Waters', after the late Len Waters (1924-1993). Mr Waters, an Indigenous Australian, left school at 13 and worked as a shearer. He joined the RAAF, qualified as a fighter pilot, and flew some 95 combat missions in New Guinea and Borneo during World War II. A number of submissions supported the adoption of his name for the new division.
31. The augmented Electoral Commission acknowledged that Mr Waters was an outstanding Australian whose achievements warrant wide recognition. His war service has been commemorated with a stamp and aerogram in Australia Post's 'Australia Remembers' series in 1995. His name is also remembered in Len Waters Park in Inala, Brisbane; Len Waters Park in Boggabilla, New South Wales; and a monument in his home town of St George, Queensland.
32. Several names were considered by the Redistribution Committee for the new division; and when more than one name is under consideration, the task of the augmented Electoral Commission should not be seen as assessing the respective worthiness of the individuals in some kind of competition.
33. It should also be noted that the *Guidelines for Naming Electoral Divisions* (Appendix G) are not prescriptive, and give both Redistribution Committees and augmented Electoral Commissions scope in selecting the names of divisions, particularly a new division.

34. In all the circumstances, and particularly having regard to the connection the late Judith Wright had with Mount Tamborine, which is in the new division, and a number of favourable submissions, the augmented Electoral Commission affirmed that the new division be named Wright.

#### ***The proposed Forde/Wright boundaries***

35. A small number of objections were received arguing that the community of interests in Forde and Wright could be improved by the transfer of peri-urban areas from Forde to Wright and the transfer of urban areas from Wright to Forde. The augmented Electoral Commission accepted this argument, as presented in the objections.
36. In considering the boundaries proposed by the Redistribution Committee, the augmented Electoral Commission agreed that the outcome sought by the objections could be achieved by the transfer of a peri-urban area from Forde to Wright. Thus, by the inclusion of the localities<sup>4</sup> of Jimboomba, Logan Village, Stockleigh and Yarrabilba, the predominantly rural characteristics of Wright are maintained.
37. Additionally, by the transfer of Boronia Heights from Wright to Forde, the augmented Electoral Commission was able to enhance the community of interests and urban character of Forde.
38. The elector transfers between Forde and Wright outlined above are within the numerical tolerances allowed for by the Electoral Act. The augmented Electoral Commission therefore upheld the objections.

#### ***The proposed Wright boundary***

39. In submissions received by the augmented Electoral Commission there was general support for the location of the new division. A small number of objections argued against the inclusion of the Lockyer Valley Regional Council in Wright. The augmented Electoral Commission, in upholding the Redistribution Committee's proposed boundaries, acknowledged that there are various communities of interests present in Wright, including those ranging from peri-urban to rural in nature. On balance, the augmented Electoral Commission agreed with the Redistribution Committee that the area of the Lockyer Valley Regional Council shares community of interests with areas of Wright to the east.
40. The augmented Electoral Commission was also cognizant of the high growth in the south-east of the state that needed to be balanced out, to meet the requirements of the Electoral Act, in the construction of the new divisional boundaries.
41. For these reasons, objections to the inclusion of the Lockyer Valley Regional Council in Wright failed.

### ***The proposed Blair/Oxley boundaries***

42. A number of objections offered alternative boundaries in the areas of Collingwood Park and Redbank Plains, and in the areas of Augustine Heights and Brookwater. However, those suggested changes, while not without merit, could not be achieved because high growth restricted the ability to meet the numerical tolerances required by the Electoral Act for enrolments. Therefore the objections in relation to this boundary failed.

### ***The proposed Moreton/Rankin boundaries***

43. The augmented Electoral Commission accepted the argument put forward that Moreton not take in any of the Logan City Council, noting that this could be achieved numerically. As such, all of the locality of Underwood shall be located in Rankin. The boundary between Moreton and Rankin shall be the same as the local government area boundary between the Brisbane and Logan City Councils. The augmented Electoral Commission upheld the objection.

### ***The proposed Moreton/Oxley boundaries***

44. The augmented Electoral Commission accepted arguments that by including more of the locality of Oxley, south of Ipswich Road, in Moreton the community of interests in Moreton could be better met. The augmented Electoral Commission also noted that this change could be achieved numerically. The objection was upheld.

### ***The proposed Brisbane/Ryan boundaries***

45. The augmented Electoral Commission considered a number of submissions that either objected to, or agreed with, the transfer of all of the 'Centenary suburbs' to Oxley. In upholding the Redistribution Committee's proposal that Wright be located to the south of Brisbane, the augmented Electoral Commission accepted that Ryan was required to lose electors to Oxley. The augmented Electoral Commission also agreed with the Redistribution Committee that the use of the Brisbane River was appropriate as an electoral boundary, on this occasion. Consequently the augmented Electoral Commission acknowledged that the 'Centenary suburbs' needed to move to Oxley in order to meet the numerical requirements of the Electoral Act. For these reasons, objections opposing the transfer of the 'Centenary suburbs' to Oxley failed.
46. The augmented Electoral Commission accepted the contention put forward that there was no need to make a change to the divisional boundary in the locality of Toowong as was proposed by the Redistribution Committee. As such, Toowong shall be located in Ryan. This objection was upheld.
47. The augmented Electoral Commission considered objections that proposed various alternative boundaries between Brisbane and Ryan. The augmented Electoral Commission agreed with the Redistribution Committee's proposal that the suburbs of Keperra and Mitchelton be kept wholly in one division. In the opinion of the augmented Electoral Commission this option better addressed the community of interests of these suburbs. As such, these objections failed.



### ***The proposed Brisbane/Lilley boundaries***

48. An issue raised in one objection related to the splitting of the horse-racing industry between two divisions, and other objections related to the use of Stafford Road as a boundary between Brisbane and Lilley.
49. The augmented Electoral Commission noted that Brisbane needed to gain electors as a result of the loss of electors to Ryan. A number of submissions agreed with the Redistribution Committee that it was appropriate that the suburbs of Albion, Ascot, Clayfield, Hamilton and Hendra be transferred to Brisbane. At the Brisbane hearing it was observed that these suburbs are becoming more inner-city focussed. As a consequence, the augmented Electoral Commission was unable to accede to the retention of the horse-racing industry in one division; hence that objection failed.
50. While acknowledging the use of Kedron Brook for a greater portion of the boundary between Brisbane and Lilley would have been desirable, as proposed in submissions, ultimately, due to the numerical constraints of the Electoral Act, the augmented Electoral Commission agreed with the use of Stafford Road as part of the boundary, as proposed by the Redistribution Committee. Therefore this objection failed.

### ***The proposed Lilley/Petrie boundaries***

51. A number of submissions objected to the proposed transfer of the Bramble Bay suburbs of Brighton, Deagon, Sandgate and Shorncliffe from Lilley to Petrie. An objection, discussed at the Brisbane hearing, suggested that only part of this area be located in Lilley. The augmented Electoral Commission decided, on balance, that community of interests were more appropriately met by locating all of the suburbs of Brighton, Deagon, Sandgate and Shorncliffe together in Lilley. Therefore, these objections were upheld.
52. As a consequence, in order to meet the numerical requirements of the Electoral Act, the augmented Electoral Commission concluded that a part of the proposed Lilley, north of Albany Creek Road and Robinson Road West, shall be located in Petrie.
53. By making the above changes to the Redistribution Committee's proposal, the augmented Electoral Commission is of the opinion that the criteria in the Electoral Act are better met, and noted that fewer electors are moved as a result of the redistribution.
54. The augmented Electoral Commission agreed with the Redistribution Committee that, by maintaining the boundary between the Brisbane City Council and the Moreton Bay Regional Council, the community of interests of the suburbs on that boundary are effectively addressed. As such, objections that propose parts of the Brisbane City Council be located in Dickson failed.

### ***The proposed Dickson/Petrie/Longman boundaries***

55. A number of submissions objected to the proposed transfer of the Dayboro/Kurwongbah areas from Dickson to Longman. The augmented Electoral Commission accepted arguments put forward in objections that community of interests were more convincingly met by those areas being located in Dickson. Therefore the augmented Electoral Commission upheld these objections and, as a result, the Dayboro/Kurwongbah area shall be located in Dickson. As a consequence, more electors in the suburb of Kallangur shall be in Longman in order to meet the numerical requirements of the Electoral Act. The augmented Electoral Commission noted that fewer electors are moved between divisions as a result of this decision.
56. A number of objections argued that Petrie should gain electors from Longman in the locality of Kallangur by moving the boundary to take in areas west of the Bruce Highway. The augmented Electoral Commission noted that this change was dependent upon Dickson moving into the northern suburbs of the Brisbane City Council. As such, these objections failed.

### ***The proposed Fairfax/Fisher boundaries***

57. A number of objections raised the issue of community of interests in respect of the localities of Palmwoods and Montville, and sought to ensure that each of these localities was in only one division. No preference was stated in the objections with respect to Montville being in either Fairfax or Fisher. The augmented Electoral Commission, in accepting these arguments, decided to locate more of Palmwoods in Fairfax, and all of Montville in Fisher.
58. Objections that argued that Buderim-Mooloolaba Road be used as the boundary between Fairfax and Fisher, failed. The transfer of electors in this area would have resulted in Fairfax being in excess of the maximum projected enrolment permitted under the Electoral Act. The augmented Electoral Commission therefore agreed with the boundaries proposed by the Redistribution Committee.
59. To ensure that the locality of Mountain Creek is located wholly in one division, the augmented Electoral Commission decided to change the boundary to follow that between the locality of Mountain Creek and the localities of Parrearra and Sippy Downs, to the Sunshine Motorway.

### ***The proposed Fairfax/Wide Bay boundaries***

60. A number of objections sought to locate the whole, or a larger part, of the Sunshine Coast Regional Council in Fairfax. Such changes could not be made without substantial changes elsewhere due to numerical constraints. Therefore these objections failed, and the augmented Electoral Commission affirms the boundary proposed by the Redistribution Committee.

### ***The proposed boundaries of the divisions of Capricornia, Flynn, Hinkler and Wide Bay***

61. Submissions to the augmented Electoral Commission raised issues that were largely interdependent in respect of these divisions, and as such are dealt with collectively.
62. The augmented Electoral Commission considered a number of submissions that either objected to, or agreed with, the location of North Bundaberg in Hinkler. In upholding the Redistribution Committee's proposal, the augmented Electoral Commission agreed that the community of interests of North Bundaberg are with the remainder of Bundaberg. A number of submissions supported this view on the basis that North Bundaberg is dependent on the area south of the Burnett River for a wide range of services.
63. As a consequence of this decision, objections which advocated subsequent boundary changes to Capricornia, Flynn, Hinkler and Wide Bay failed, due to numerical restrictions. Hence, the augmented Electoral Commission agreed that the Redistribution Committee's proposal better met the criteria of the Electoral Act, and objections to the boundaries of Capricornia, Flynn, Hinkler and Wide Bay failed.

### ***The proposed Dawson/Herbert boundaries***

64. Approximately 450 objections opposed the proposed transfer of the localities of Annandale and Wulguru from Herbert to Dawson. Written objections, and submissions made at the public inquiry held in Townsville, argued that the community of interests and transport connections of these localities are with Townsville, and that access to the Member of Parliament would be restricted.
65. It should be noted that the basis of any redistribution is to ensure equality of representation, as defined under the Electoral Act, with respect to the number of electors in each federal division. At the projection date of 9 July 2012, the maximum number of electors in a division is 100 635. At that time, Herbert is projected on its existing boundaries to contain 102 521 electors, which includes a projected 1 003 electors in the Palm Island Shire and Hinchinbrook Shire (the Palm Islands). The augmented Electoral Commission agreed with the Redistribution Committee's proposal that the Palm Islands remain in Herbert, on community of interests grounds.
66. If all—and only—electors of the Townsville City Council were in Herbert, as was argued in some submissions, the resultant Herbert would be projected to contain 118 343 electors. This results in 17 708 electors in excess of the maximum projected enrolment permitted under the Electoral Act. Therefore, with the decision to retain the Palm Islands in Herbert, at least 18 711 electors in the Townsville City Council cannot be included in Herbert.
67. Also raised in objections was the proximity of Annandale to Lavarack Barracks, and the fact that a number of Annandale residents are employed at the barracks. The augmented Electoral Commission agreed with the Redistribution Committee's proposal to locate Lavarack Barracks in Herbert on the basis of the association of this military base with Townsville, not just with the residents of Annandale.

68. The augmented Electoral Commission acknowledged the comments of the Redistribution Committee that ‘... boundaries gradually move into regional centres over the course of successive redistributions’<sup>5</sup> and the ‘enrolment projections do not ... allow all regional centres ... to be contained entirely within electoral divisions without significant changes to existing boundaries. Such boundary changes would have a major and, in the estimation of the Committee, undesirable impact on electors’.<sup>6</sup>
69. The augmented Electoral Commission also noted that the encroachment of other divisions into Herbert, taking electors from the Townsville City Council, reflects what has occurred in previous redistributions due to population growth and the resultant projected enrolment figures. At the Townsville hearing it was suggested that this encroachment pattern should be projected two redistributions into the future. As such, short-term implications and probable longer-term outcomes of redistributions could give the public a better understanding of this electoral process.
70. The circumstances of each redistribution must, by necessity, deal with the issues that are relevant to the timeframe under consideration, and each redistribution must comply with the legislation in place at that time. Augmented Electoral Commissions have no role in forecasting issues that may impact upon the deliberations of future Redistribution Committees and augmented Electoral Commissions.
71. The augmented Electoral Commission, in acknowledging the merits of the submissions, explored a number of options to locate Annandale and/or Wulguru in Herbert. These were:
- the transfer of other parts of the Townsville City Council from Herbert;
  - retaining part of Annandale in Herbert, which would have seen Annandale split between two divisions;
  - a major redrawing of boundaries, which could have impacted on other areas, such as Charters Towers and Palm Island; and
  - the equal division of the Townsville City Council into two federal divisions.
72. The augmented Electoral Commission carefully considered these options in an endeavour to find an alternative to accommodate the number of electors that exceeded the maximum projected enrolment permitted under the Electoral Act. Ultimately, the augmented Electoral Commission was unable to identify a viable alternative which satisfactorily met the requirements of the Electoral Act. As such, the objections failed.
73. The augmented Electoral Commission noted that, following its decision to affirm the boundaries for Herbert as proposed by the Redistribution Committee, of the 100 252 projected electors in Herbert, 99 249 are from the Townsville City Council. This represents 83.87% of the total projected enrolment of the Townsville City Council.

### ***The proposed Dawson/Kennedy boundaries***

74. One objection questioned the inclusion of a single CCD (3050113) from the Burdekin Shire Council in Kennedy. That CCD could not be located in Dawson without changes elsewhere to Dawson, hence the objection failed.
75. The augmented Electoral Commission acknowledged the intent of the objection and sought to strengthen the boundary in this area by moving an additional CCD (3050114) from Dawson to Kennedy, thus making greater use of the Burdekin River as the boundary between Kennedy and Dawson.

### ***The proposed Kennedy/Leichhardt boundaries***

76. A number of objections concerned the boundary between Kennedy and Leichhardt, particularly in respect of Edmonton and Kuranda. Leichhardt must lose approximately 7 200 electors due to projected high enrolment growth, primarily in the Cairns Regional Council.
77. It was submitted that the existing boundary along the Mitchell River had been in place for a period of time and is well-known, and that change was unnecessary. The augmented Electoral Commission agreed with this argument and concluded that the boundary in this area shall be the Mitchell River. Therefore, these objections were upheld.
78. The augmented Electoral Commission considered the objections regarding areas of the Tablelands Regional Council, including Kuranda, being moved to Kennedy as proposed by the Redistribution Committee. The augmented Electoral Commission accepted the argument that Kuranda has strong community of interests with Leichhardt due to its links with Cairns. On this basis, and as the numerical requirements of the Electoral Act are satisfied, the objections in relation to Kuranda are largely upheld. The boundary between Kennedy and Leichhardt shall be the Clohesy and Barron Rivers and Armstrong, Mona Mona and Black Mountain Roads.
79. The augmented Electoral Commission considered the objections which opposed the transfer of Edmonton to Kennedy. That Edmonton, as part of Cairns City Council, has community of interest links with Leichhardt was acknowledged by the augmented Electoral Commission. However, because Leichhardt must lose electors in order to meet the numerical requirements of the Electoral Act, and the decisions above, the only place sufficient electors can be found is by the transfer of Edmonton from Leichhardt to Kennedy. As such the augmented Electoral Commission adopted the Redistribution Committee's proposal in respect of the boundary in the Edmonton area. Therefore, these objections failed and the boundary shall be between the localities of Edmonton and Bentley Park.
80. In locating Kuranda in Leichhardt, in the opinion of the augmented Electoral Commission, all criteria of the Electoral Act are suitably met. The augmented Electoral Commission also noted that fewer electors will be moved as a result of the redistribution.

### ***The proposed Flynn/Maranoa boundaries***

81. One objection sought to retain the Longreach Regional Council in Flynn rather than transfer it to Maranoa. The augmented Electoral Commission noted that Maranoa had to gain some 3 000 electors. Objections supporting the transfer from Flynn to Maranoa of the Barcaldine, Blackall-Tambo, Longreach and Winton local government areas expressed the view that their community of interests would be better met by that transfer. In light of the support expressed for the transfer, and given that the numerical requirements of the Electoral Act were met, the augmented Electoral Commission accepted the Redistribution Committee's proposal. The objection regarding the retention of the Longreach Regional Council in Flynn failed.
82. Another objection, regarding the boundaries of Flynn and Maranoa, argued that the Dalby Regional Council (now Western Downs Regional Council) should be located wholly in Maranoa. In the opinion of the augmented Electoral Commission, the community of interests would be better met by Dalby Regional Council not being split between two federal divisions. As such, the objection was upheld and all of the Dalby Regional Council shall be located in Maranoa.

### ***Other objections to proposed boundaries***

83. A number of submissions commented on the boundaries of rural divisions moving into regional centres over this and recent redistributions. An argument is that each major regional centre should be wholly located within one division. It was the opinion of the augmented Electoral Commission that the population distribution, enrolment growth and geography of Queensland do not permit this to occur within the framework of the Electoral Act, at this time.
84. In view of all of the considerations above, the augmented Electoral Commission accepts the Redistribution Committee's proposal, as amended in this report.

### **Whether the augmented Electoral Commission's proposal is 'significantly different' from the Redistribution Committee's proposal**

85. The augmented Electoral Commission's decision to affirm the Redistribution Committee's proposal subject to the stated changes, leaves a further question outstanding under section 72(12) of the Electoral Act. This question is whether, 'in the opinion of the augmented Electoral Commission', its proposal is 'significantly different' from that of the Redistribution Committee.
86. The augmented Electoral Commission accepted the location and name of the new division as proposed by the Redistribution Committee, with only a small adjustment to its boundaries. Changes to the boundaries which have been made elsewhere by the augmented Electoral Commission do not, in its view, alter the substance of the Redistribution Committee's proposal.

87. Considering all of the changes together, the augmented Electoral Commission is of the opinion that its proposal is not significantly different from the Redistribution Committee's proposal within the meaning of section 72(12) and it has so determined.

**Determination made by the augmented Electoral Commission for Queensland**

88. For the foregoing reasons stated under section 74 of the Electoral Act, the augmented Electoral Commission, having considered all objections, comments on objections and submissions, made the determination, the terms of which are set out above, by notice published in the Gazette on the 15<sup>th</sup> day of December 2009. The augmented Electoral Commission issued a public announcement in compliance with section 72(10) and (12) of the Electoral Act on 16 October 2009. As a consequence of the opinion stated in paragraph 87 there was no cause for the augmented Electoral Commission to issue the invitation for further objections or to hold the inquiry as referred to in section 72(12)(d) and (13) of the Electoral Act.

## **1.4 DESCRIPTION OF THE METHOD USED TO CALCULATE THE AREA OF ELECTORAL DIVISIONS**

The area of electoral divisions in Queensland has been calculated by aggregating the area of:

- all land-based CCDs;
- any parts of land-based CCDs; and
- any lakes, ponds, rivers, creeks, wetlands or marshes not already included in land-based CCDs that are wholly contained within the divisional boundary of each electoral division.

Areas are calculated on the *Geocentric Datum of Australia (GDA94)* spheroid using the AEC *Electoral Boundary Mapping System (EBMS)* developed within the 'MapInfo Professional' software package.

## 1.5 GENERAL DESCRIPTION OF EACH ELECTORAL DIVISION

The tables on the following pages set out how each electoral division is constituted and arranged under SLAs. Each SLA comprises a number of CCDs. The CCDs which applied at the 2006 Census of Population and Housing have been used.

## **APPENDIX G: GUIDELINES FOR NAMING ELECTORAL DIVISIONS**

Naming of federal divisions has been the subject of a number of recommendations from Parliamentary Committees. The subject was dealt with most recently by the 1995 Inquiry of the Joint Standing Committee on Electoral Matters. From these recommendations a set of guidelines or conventions has been developed and these are referred to by Redistribution Committees and augmented Electoral Commissions.

The guidelines are used in situations where divisions are to be created or where divisions are to be abolished during a redistribution process and are offered to interested persons in the advertising of redistributions.

It should be noted that neither Redistribution Committees nor augmented Electoral Commissions are in any way bound by the guidelines which are reproduced below.

### **Naming after persons**

In the main, divisions should be named after deceased Australians who have rendered outstanding service to their country. When new divisions are created the names of former Prime Ministers should be considered.

### **Federation Divisional names**

Every effort should be made to retain the names of original federation divisions.

### **Geographical names**

Locality or place names should generally be avoided but in certain areas the use of geographical features may be appropriate (e.g. Perth).

### **Aboriginal names**

Aboriginal names should be used where appropriate and as far as possible existing Aboriginal divisional names should be retained.

### **Other criteria**

- The names of Commonwealth divisions should not duplicate existing State Districts.
- Qualifying names may be used where appropriate (e.g. Melbourne Ports, Port Adelaide).
- Names of divisions should not be changed or transferred to new areas without very strong reasons.
- When two or more divisions are partially combined as far as possible the name of the new division should be that of the old division which had the greatest number of electors within the new boundaries. However where the socio-demographic nature of the division in question has changed significantly this should override the numerical formula.
