





Introduction

I am providing comment on most of the suggestions submitted for the redistribution of Western Australia electoral divisions.

Ideally, I would provide comments on every suggestion, however, given the number of statewide suggestions, and the short timeframes to provide comments and within the environment of redistributions occurring in New South Wales and Victoria, I do not have time to undertake a thorough analysis of all suggestions in detail.

Therefore, I will focus on some general themes found in the drawing of boundaries, and suggestions for names of the new division.

General themes presented in suggestions.

Most suggestions recommend that a new division be created by splitting most of the existing division of **HASLUCK**. The new division is then created either in the north-eastern suburbs of Perth, incorporating most of the City of Swan or, in most cases, the south, including most of the City of Kalamunda. The remaining parts then constitute the new division of **HASLUCK**.

Of the statewide suggestions, all of **Suggestion 7 - Jeff Waddell** and **Suggestion 12 - Martin Gordon** and **Suggestion 14 - Dr Mark Mulcair** have almost the same general approach as mine, which should indicate our suggestions are logical and reasonable. We seem to agree on most of the inner divisions, with only minor variations on specific borders.

We have taken different approaches for **Forrest** and **Canning**. I prefer the neatness of **Canning** in my own submission but acknowledge this leaves **Forrest** with less than ideal boundaries. It would be up to the Committee to decide whether to improve **Forrest** at the expense of either **O'Connor** or **Canning** or vice versa.

Suggestion 8 - Ben Close is similar in many regards, although I feel some of the boundaries applied twist and turn a bit, and his versions of **Burt**, **Fremantle** and **Tangney** seem disjointed. Meanwhile, **Suggestion 21 - Luke Dixon** seems again similar in some parts, but makes unnecessary exchanges between **Fremantle** and **Brand**, which has flow on effects to **Canning** and **Forrest**.

I will leave the **Suggestion 16 - Liberal Party of Australia (WA Division)** and **Suggestion 18 - WA Labor** to comment by others, although I will make one observation that they generally align with the submissions of the rest of us, with a few notable (and probably political) exceptions.

I do not support any suggestions that propose a geographic-based name for a new division. Assigning a geographic name for a new division is contrary to the Guidelines for naming federal electoral divisions and therefore cannot be supported.

Of the suggestions for a division named for an individual, I support using the name to increase diversity and honour someone who may otherwise go unrecognised. This therefore means that I do not support a division named Chaney, Court, Rocher or Walsh.

I would support any of the names, YAGAN, BATES, BRIDGE or DUNN put forward by **Suggestion**11 - Nimalan Sivakumar as all of these individuals are worthy of recognition. I note that this aligns with my suggestion for a division named BATES. I had also considered a division named BRIDGE in my suggestion.

A division named after Graham Farmer

Suggestion 18 - WA Labor proposed a new division named **FARMER** after Graham Polly" Farmer MBE. Farmer was first and foremost a footballer and his achievements relate only to his time playing football. While he did create the Polly Farmer Foundation, which was established to help indigenous youth, this achievement in itself is not what he is known for.

Sports persons are not represented in electoral division names and I believe this is for a good reason. Australian society already places a large (some would say inflated) emphasis on sport. Athletes are held in high regard, but their achievements are mostly personal, individual or team-based. Other than the feeling of goodwill, high spirits or a morale-boost, sporting achievements from individuals or teams do not provide any actual benefit or advantage to the greater population. For this reason, I believe sport stars should be appropriately commemorated in the sporting arena, the media, or with statues, monuments or buildings.

But not in electoral divisions. I feel that electoral division names should reflect those members of society that often go unrecognised. Contemporary candidates in social, political, scientific, artistic, academic, economic or other fields, should be honoured. Sports stars are well-recognised already in their own arena. Should a sports star become involved in one of these other fields either during or after their time in sport, that their contribution in these fields alone warrants recognition, then I have no problem honouring them with a division name.

Farmer's name is given to the Graham Farmer Freeway in Perth, he was named in one of the 150 bronze tablets commemorating the *WAY 1979* celebrations. He has been inducted into the AFL and WAFL Hall of Fame and teams of the century for the three teams in which he played. As such, there are significant legacies dedicated to his memory and I don't believe a division should be named Farmer in his honour.

A division named after Charles Court

Suggestion 16 - Liberal Party of Australia (WA Division) as well as Suggestion 6 - Peter Stewart CFP AEPS FAFA Dip FP Dip LI JP and Suggestion 21 - Luke Dixon all propose a new division named Court after the premier of Western Australia the Hon Sir Charles Walter Michael Court AK KCMG OBE.

This is not the first time **COURT** has been suggested as division name in a Western Australia redistribution, the Liberal Party has now made this suggestion three times, seemingly unable to find a single other individual in Western Australia worthy of nomination for an electoral division.

I had previously objected to a division named **COURT** on the basis that the name could be confused for his still living son. Richard Court, being a more recent premier, and a somewhat controversial figure, could lead to objections about the name. This would be similar to the proposal in 2006 to name a new division in Queensland after poet Judith Wright. Objections to the division of **WRIGHT** were based on the association with the name. The local prominence of

a disgraced politician with the same surname was enough to reject the name at that redistribution.

I believe the associations of the name Court with Richard Court would be very real in this case. I believe this may be further compounded with Charles's daughter-in-law, Margaret Court leading to even greater confusion. Her recent commentary, in particular in relation to marriage equality, could also lead to associations not appropriate for a division name. These reasons alone would be sufficient to not support a division named Court.

However, when looking more closely at the conduct of Charles Court himself, I feel that he does not deserve a division named for him on merit.

Charles Court was a state premier of Western Australia. He never represented Western Australia in the federal parliament or in an administrative role, such as a governor, governor-general or diplomat.

State premiers have featured in electoral division names, but they should not be automatically considered. Only twelve divisions named for a state premier (who didn't also serve as a prime minister or High Court judge) exist today. Of these, only **Dickson** and **Solomon** were created after the creation of **Brand** in the 1984 expansion of Parliament. I would suggest that state premiers should now only be considered for a division name where their service was longevous, extraordinary or otherwise remarkable.

Charles Court's premiership was neither of these. He was the sixth longest serving premier, which itself is hardly remarkable. His achievements in opening the state to mining opportunities may be well received, however I believe his conduct and behaviour in two areas disqualifies him from holding the distinction of a division name.¹

Court was a staunch opponent of Aboriginal land rights. He played a significant role in the infamous Noonkanbah land-rights dispute. Despite evidence that the Yungngora people's Noonkanbah pastoral station in the Kimberley held anthropological and spiritual significance, Court insisted that exploration and drilling go ahead, leading to violent confrontation and protests. This chapter has been viewed by some as a problematic legacy of Court's premiership.

Secondly, Court introduced laws to restrict public gatherings. Changes to the Police Act, prevented gatherings of more than three persons without police permission. This was controversial at the time, and would still be considered controversial today. Indeed, similar laws in Queensland were repealed, and there were protests over this type of restriction, albeit temporarily, during the Covid-19 pandemic.

Finally, Court was an avowed anti-centralist and opposed federal government encroaching upon what he believed to be the rights of states. While there is no issue with this attitude, it would become somewhat ironic that a federal electoral division bears the name of a state premier with views that were not favourable toward a federal government.
