1.1 DETERMINATION MADE BY THE AUGMENTED ELECTORAL COMMISSION FOR VICTORIA

Pursuant to section 73 of the *Commonwealth Electoral Act 1918* (the Act), the augmented Electoral Commission for Victoria hereby determines that the boundaries and names of the Electoral Divisions into which the State of Victoria is to be distributed are as shown on the maps certified by the members of the augmented Electoral Commission for Victoria and lodged in File Number 2002/1773 at the Principal Office of the Australian Electoral Commission in Canberra. 1.2 PROCESS FOLLOWED BY THE AUGMENTED ELECTORAL COMMISSION FOR VICTORIA IN MAKING ITS DETERMINATION

- 1. Notice of the Redistribution Committee's proposal was published in the Commonwealth Gazette on 30 August 2002. Outline maps of the proposed redistribution by the Redistribution Committee for Victoria and a notice inviting Public Objections and Comments on Public Objections against the proposal were published in "The Age" and the "Herald Sun" newspapers on 30 August 2002. In addition, the section 68 report was made available for public inspection at all offices of the AEC in Victoria. Furthermore, the section 68 report, outline maps and Public Suggestions and Comments on Public Suggestions were posted to the AEC website, www.aec.gov.au on 30 August 2002.

- 6. In accordance with section 72(3) of the Act, the augmented Electoral Commission held a public inquiry into Public Objections on Thursday, 14 November 2002. The inquiry was advertised in "The Age" and the "Herald Sun" newspapers on Monday, 11 November 2002. A transcript of the inquiry is included on the compact disc accompanying this report. 7. The augmented Electoral Commission during its deliberations considered all Public Objections, Comments on Public Objections and supporting documentation tabled at the inquiry.

- 8. In accordance with section 72(10)(b) of the Act, the augmented Electoral Commission issued a public announcement on 19 December 2002 that it had concluded its deliberations on the new boundaries and names of the 37 Divisions for Victoria.
- 9. This report of the augmented Electoral Commission's determination is published in accordance with sections 73 and 74 of the Act.

1.3 REASONS FOR THE DETERMINATION MADE BY THE AUGMENTED ELECTORAL COMMISSION FOR VICTORIA

Consideration of Public Objections to the Redistribution Committee proposal

Objections to the proposed Divisions of Aston, Deakin, La Trobe and Menzies

- 10. The augmented Electoral Commission received a number of objections to the proposed boundary between the Divisions of Deakin and Menzies in which most suggested the existing boundary between both Divisions rather than the boundary proposed by the Redistribution Committee for Victoria. The augmented Electoral Commission acknowledged the clearer boundary raised by the objections and adopted the pre-existing Glenvale and Oban Road boundary between the Divisions of Deakin and Menzies.
- 11. As a result of the above change, two objections to the proposed Aston/Deakin divisional boundary were able to be accommodated by retaining the existing Aston/Deakin boundary at Canterbury and Springvale Roads.
- 12. Two objections (involving no electors) supporting the retention of several campuses of Monash University within the Division of La Trobe were also upheld by the augmented Electoral Commission.

Objections to the proposed Divisions of Batman and Melbourne

13. One objection suggested the retention of the existing Division of Melbourne boundary with the consequent return of the Alphington area to the Division of Batman. The augmented Electoral Commission determined that the Redistribution Committee's proposal was satisfactory and the Committee's principle of maintaining Local Government boundaries was appropriate in this area.

Objections to the proposed Divisions of Bruce, Holt and Isaacs

14. Two objections suggested the use of the Dandenong railway line and the Princes Highway as a better boundary between the Divisions of Bruce and Isaacs than that proposed by the Redistribution Committee for Victoria. The augmented Electoral Commission recognised the clearer boundary and adopted this change.

15. An objection to the boundary between the Divisions of Holt and Isaacs - suggesting the retention in the Division of Holt of approximately 100 electors in the City of Casey - was also received. The augmented Electoral Commission upheld the objection and determined that the boundary between the Divisions of Holt and Isaacs move from the Frankston/Dandenong Road to the Dandenong/Hastings Road.

Objections to the proposed Divisions of Dunkley and Flinders

16. Objections were received suggesting the retention of the pre-existing boundary at Mornington between the Divisions of Dunkley and Flinders and aligning the south-eastern corner boundary of the Division of Dunkley with the City of Frankston boundary. The augmented Electoral Commission opted to retain the pre-existing boundary between Dunkley and Flinders at Mornington and aligned the south-eastern corner boundary of the Division of Dunkley with the City of Frankston boundary.

Objections to the proposed Divisions of Calwell, Gorton and Maribyrnong

- 17. A number of specific objections and consequential objections were received in relation to these Divisions. Firstly, a clearer boundary between the Divisions of Gorton and Maribyrnong was suggested in two areas Western Ring Road and Kororoit Creek. The augmented Electoral Commission determined to adopt the more clearly defined boundaries as proposed by the objectors. The transfer of part of the town of Diggers Rest from the Division of Lalor to the Division of Gorton was not agreed, on the basis that the compensating movement of electors would affect neighbouring divisions' boundaries.
- 18. An objection was received suggesting that the suburb of Brooklyn be contained wholly within the Division of Gellibrand. In following the principle of aligning divisional and municipal boundaries wherever possible, the augmented Electoral Commission rejected this objection and determined this particular area remain in the Division of Maribyrnong.
- 19. One objection suggested that the area of Sunbury, Gisborne and Macedon (i.e. the retention of certain elements of the Division of Burke) be transferred to the Division of McEwen. The augmented Electoral Commission recognised the disadvantages associated with the numerous compensating movement of electors that would be required to accommodate this change and determined to reject this objection.
- 20. An objection suggesting the four western suburban proposed Divisions of Gellibrand, Gorton, Lalor and Maribyrnong be changed significantly resulting in the possible retention of the Division of Burke was considered by the augmented Electoral Commission. The augmented Electoral Commission determined that the boundaries proposed by the Redistribution Committee for Victoria in this region were appropriate considering the numerous compensating movement of electors that would be required to meet this objection.
- 21. Two objections concerning the proposed Division of Calwell suggested that the area of Craigieburn be transferred to the Division of McEwen. The augmented Electoral

Commission endorsed the Redistribution Committee's proposal to align the Calwell divisional boundary with the City of Hume (which includes the Craigieburn area) and determined to reject this objection.

Objections to the proposed Divisions of Gellibrand and Lalor

- 22. The augmented Electoral Commission received several objections regarding the transfer of Altona, Altona Meadows and Seabrook from the Division of Lalor to the Division of Gellibrand. The augmented Electoral Commission determined that the number of electors involved in such a change would not be able to be accommodated without major compensating movement of electors in surrounding Divisions.
- 23. An objection suggesting an improvement in the boundary of the Divisions of Gellibrand and Lalor along the Princes Freeway near Laverton was adopted by the augmented Electoral Commission as a better boundary than that proposed by the Redistribution Committee.

Objections to the proposed Divisions of Jagajaga and Scullin

24. Two objections were received concerning the boundaries of the Divisions of Jagajaga, Scullin and McEwen. The augmented Electoral Commission recognised the need for a clearer boundary between Jagajaga and McEwen and determined a more discernible boundary by adopting the Research/Warrandyte Road and the suburb boundary of North Warrandyte.

Objections to the proposed Division of Mallee

25. A series of objections was received relating to the transfer of the whole of Gannawarra Shire from the Division of Murray to the Division of Mallee. The augmented Electoral Commission determined that the transfer of electors was necessary to counter the low population growth in this area and noted that the Redistribution Committee's proposal was in keeping with the aim of aligning divisional and municipal boundaries intact wherever possible and accordingly the objections were rejected.

Objections to the proposed Divisions of Bendigo, Indi, McEwen and Murray

- 26. A number of objections were received regarding the proposed boundaries in this part of the State. The first group of objections related to the proposed transfer of the Mansfield district from the Division of McEwen to the Division of Indi. A further objection suggested the transfer of the Seymour area into the Division of Indi which would, in turn, allow the Mansfield district to remain within the Division of McEwen.
- 27. The augmented Electoral Commission determined that the Redistribution Committee had proposed an appropriate boundary between the Divisions of Indi and McEwen and that the community of interest arguments of the objections did not support a change in this area. The Committee noted the recent changes to the former Shire of Delatite but concluded the both parts of the former Shire be included in the Division of Indi.

- 28. A second series of objections related to the Macedon Ranges Shire and the suggestion to include the Shire entirely within the Division of McEwen. Another objection suggested the Shire be split between the Divisions of Calwell and Bendigo with the majority of electors transferring to the Division of Calwell. A similar number of electors would then transfer from the Division of Calwell to the Division of McEwen to compensate for the change, as well as a small number of electors transferring from the Division of Bendigo to the Division of Murray. The augmented Electoral Commission determined that the Redistribution Committee's proposal involving these Divisions was acceptable in terms of community of interests, particularly given the significant movement of electors suggested by the objections.
- 29. A detailed objection relating to various changes involving Bendigo, Indi, McEwen, Mallee and Murray was also considered. The suggestion was for the Gannawarra area to be returned to the Division of Murray, part of the Loddon Shire and the towns of Heathcote and Elmore transferred from the Division of Bendigo to the Division of Murray, and a considerable number of electors in the Kyneton and Woodend areas transferred from the Division of McEwen to the Division of Bendigo. The augmented Electoral Commission determined that the disadvantages associated with the numerous compensating transfer of electors outweighed the merit of the objection.
- 30. Another objection suggested that the Yarrawonga area be returned to the Division of Indi. The augmented Electoral Commission determined that the consequential boundary changes and transfer of electors required to uphold the objection were such as to outweigh the merits of the objection.

Objections to the proposed Division of Corangamite

31. An objection relating to the Division of Corangamite suggested the movement of Lake Corangamite back to the Division of Corangamite from the Division of Wannon (no electors involved). Although for the purposes of naming, this objection had some merit, the augmented Electoral Commission determined that the Redistribution Committee's rationale of maintaining municipal boundaries wherever possible was appropriate in this particular area and determined that Lake Corangamite be retained in the Division of Wannon.

Objections to the proposed Division of Wannon

32. One objection related to the transfer of the Dergholm area from the Division of Wannon to the Division of Mallee. The augmented Electoral Commission determined that the Redistribution Committee's proposal was appropriate given the aim of retaining entire municipal boundaries in a particular Division wherever possible.

Objections to the proposed Divisions of Gippsland and McMillan

33. A number of objections were received regarding the impact on local communities of the proposed transfer of Traralgon from the Division of McMillan to the Division of Gippsland. Three detailed objections relating to the two Divisions were also received.

- 34. The first of the detailed objections suggested transferring all of the Shire of South Gippsland together with a portion of the Shire of Bass Coast from the Division of Gippsland to the Division of McMillan. A small compensatory transfer of approximately 800 electors was suggested between the Divisions of Flinders and McMillan at Nyora.
- 35. The second detailed objection suggested that the Morwell area should be relocated into the Division of Gippsland, together with Traralgon, and that the southern boundary of the Division of McMillan be extended southward to the coast.
- 36. The third detailed objection suggested that the Division of Gippsland be comprised of the entire Shires of East Gippsland, Wellington, South Gippsland and Bass Coast and that the Division of McMillan be comprised of the City of La Trobe in its entirety, the Shire of Baw Baw and part of the Shire of Cardinia.
- 37. In considering the merits of the many objections, the augmented Electoral Commission noted the Redistribution Committee for Victoria's consideration of transferring Morewell and Traralgon into Gippsland and their ultimate proposal to transfer Traralgon only. It was also mindful of the Redistribution Committee's objective to align divisional and municipal boundaries wherever possible. At the same time, the Commission was made aware of several strongly held views of the various community of interests in the two Divisions, particularly in relation to the Shire of South Gippsland and the City of La Trobe.
- 38. In reaching its view, the augmented Electoral Commission considered that the splitting of the Shire of South Gippsland in the way proposed by the Redistribution Committee for Victoria was not a preferred course of action. It would result in the separation of towns along the South Gippsland Highway from the hinterland. Consequently, the augmented Electoral Commission determined that the entire Shire of South Gippsland be transferred to the Division of McMillan, together with a small number of electors in Nyora from the Division of Flinders, to the Division of McMillan to create, in effect, a west Gippsland division.
- In considering how best to set the boundary between the Divisions of McMillan and Gippsland, the augmented Electoral Commission's attention was drawn to relevant Census data. The Commission also sought to minimise disruption to electors in the City of La Trobe. On balance, the Commission was persuaded that the transfer of Traralgon as proposed by the Redistribution Committee for Victoria, was not the preferred course of action. Accordingly, the augmented Electoral Commission determined to keep the larger towns of Morwell and Traralgon, and the towns they serve, together in the one Division by transferring them to the Division of Gippsland and drawing the electoral boundary between the Divisions of McMillan and Gippsland to the east of Moe thereby retaining the majority of the City of La Trobe in the one Division.

Names of Proposed Divisions

40. One objection was received relating to the name McMillan for that particular Division. Mindful of the naming conventions for electoral divisions, the augmented Electoral Commission determined that the changes in the Division of McMillan were not sufficient to warrant a name change and the name McMillan would remain.

Displacement of electors

41. Under the augmented Electoral Commission's determination, the number of electors that will be transferred to a different Division is 433,799, which still equates to approximately one in eight electors of the State at 18 January 2002, the quota date.

Significance of changes to the Redistribution Committee proposal

42. The augmented Electoral Commission determined that, in accordance with the provisions of the Act, the changes to the Redistribution Committee for Victoria's proposal for the State were not significant. Consequently, in accordance with section 72(13) of the Act, the augmented Electoral Commission's proposal is not open to further objection and the 2002 - 2003 Redistribution of Victoria into 37 Electoral Divisions is now concluded.

The tables in the following pages set out how each proposed Division is constituted and are arranged under Statistical Local Areas (SLAs). Each SLA comprises a number of CCDs that applied at the 1996 Population Census.

The SLA is the most widely used unit in the presentation of Census data and collectively covers the whole of Victoria without gaps or overlaps. SLAs correspond, in the majority of cases, to Local Government Areas (LGAs). Where a particular LGA is substantially different from the general run of LGAs in terms of size and economic significance, the LGAs can be split into a number of SLAs. For reasons of availability of data, the SLAs used for this redistribution are those in place at the 1996 Census.

APPENDIX E GUIDELINES FOR THE NAMING OF COMMONWEALTH ELECTORAL DIVISIONS

Several Commonwealth Parliamentary committees have considered guidelines for naming Electoral Divisions. The guidelines below were affirmed by the Joint Standing Committee on Electoral Matters in 1995. The Redistribution Committee for Victoria and the augmented Electoral Commission for Victoria took these guidelines into account when considering the names of Electoral Divisions. It should be noted that neither the Committee nor the augmented Commission are in any way bound by them.

Naming after persons

In the main, Divisions should be named after deceased Australians who have rendered outstanding service to their country.

When new Divisions are created the names of former Prime Ministers should be considered.

Federation Divisional names

Every effort should be made to retain the names of original Federation Divisions.

Geographical names

Locality or place names should generally be avoided, but in certain areas the use of geographical features may be appropriate.

Aboriginal names

Aboriginal names should be used where appropriate and as far as possible existing Aboriginal Divisional names should be retained.

Other criteria

- The names of Commonwealth Divisions should not duplicate existing State Districts.
- Qualifying names may be used where appropriate (eg Melbourne Ports, Port Adelaide).
- Names of Divisions should not be changed or transferred to new areas without very strong reasons.
- When two or more Divisions are partially combined, as far as possible the name of the new Division should be that of the old Division which had the greatest number of electors within the new boundaries. However, where the socio-demographic nature of the Division in question has changed significantly, this should override the numerical formula.
