Re: SUBMISSION RE ELECTORAL BOUNDARY REDISTRIBUTION

Reference is made to your Media Release dated 2 April 2009 inviting submissions into the redistribution of federal electoral boundaries.

Council formally received the media release at its meeting on 14 April 2009 when it resolved to lodge a submission on behalf of its residents who are affected by the current and possible changes to the electoral boundaries.

Willoughby City Council Area

- 1. Willoughby City Council is 23 square kilometres in area.
- 2. It is currently represented by 3 federal electorates Bradfield, North Sydney and Warringah.
- 3. The bulk of the Council area is in the North Sydney electorate. The Bradfield and Warringah electorates take in relatively small areas on the Council's northern and eastern boundaries respectively (see attached maps)

Submission

- 1. Council believes that its residents are disadvantaged by being divided between three federal electorates.
- 2. Of particular concern is the Warringah electorate that takes in a small section of Willoughby comprising the suburbs of Castle Cove and Middle Cove.
- 3. These two suburbs are separated from the rest of the Warringah electorate by Middle Harbour.
- 4. Apart from being separated physically, the residents share virtually no community of interest with the bulk of the Warringah electorate.
- 5. The residents of Castle Cove and Middle Cove have a strong affiliation with Willoughby. The majority of the services they access (eg schools, churches, sporting organisations etc) and the community facilities they utilise are located in Willoughby. Similarly, the commercial and retail destinations these residents use would be predominantly located in Willoughby, i.e. Chatswood, St Leonards and Northbridge.






