This has been escalated to the Elections Branch on the advice of Paul Pirani and the video has been hidden from the AEC Facebook page.

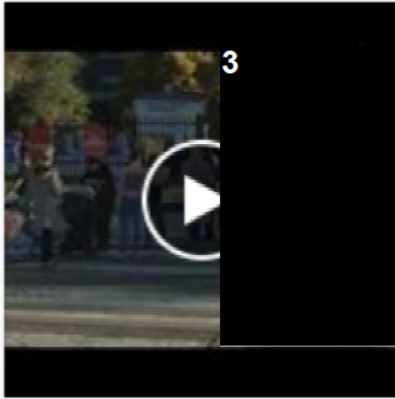
