As discussed, the attached youtube clip: 13 [REDACTED] shows a man voting multiple times in the recent Federal election. Indeed, he produced the video with the intention to demonstrate how he was able to vote multiple times.

Multiple voting is an offence against the Electoral Act – Sect 339 Sub-section (1A). An offence against subsection (1A) is an offence of strict liability.

I will formally refer this to the AFP tomorrow.
