PLEASE NOTE:

2. In order to be able to be received by the AEC, emails (including attachments) should be no greater than 6 MB in size.

Withdrawing Nominations

Nominations cannot be withdrawn after 5:00pm Local Time (office of the Returning Officer) on 13/08/2018.

Candidate Statements

In accordance with the Tasmanian Federal Branch Rule 32(7), a candidates may submit a statement (together with a passport-size photograph of the candidate if desired) to be included with ballot material. Such statement (together with any photograph) must not exceed 200 words and must be submitted as a doc or docx file to vicelections@aec.gov.au. Candidates are also required to sign a declaration taking responsibility for the accuracy of the information contained in the statements they provide. Only statements which comply with the Rules and are received by the Returning Officer by 5:00pm (Local Time (office of the Returning Officer)) on 20/08/2018 can be accepted.

Voting Period

The ballot, if required, will open on 03/09/2018 and close at 5:00pm Local Time (office of the Returning Officer) on 24/09/2018.

Scrutineers

The appointment of scrutineers opens 13/08/2018 and closes 5:00pm Local Time (office of the Returning Officer) on 24/09/2018.

A form is available from the Returning Officer for the purposes of appointing Scrutineers.
