**Withdrawing Nominations**

A candidate who has been nominated in an election may, by notice in writing addressed to the Returning Officer, withdraw the nomination at any time before the printing of the ballot papers.

**Voting Period**

The ballot, if required, will open on 1 April 2019 and close at 12:00pm (noon) Australian Eastern Standard Time (AEST) on 29 April 2019.

**Scrutineers**

Candidates shall, before the closing of nominations, notify the Returning Officer in writing of the name of scrutineer(s). The appointment of scrutineers closes 5:00pm Australian Eastern Daylight Time (AEDT) on 21 February 2019.

A form is available from the Returning Officer for the purposes of appointing Scrutineers.
