A Candidate may submit statement not exceeding 200 words and passport sized photograph for inclusion with ballot material. The statement should be provided in word format and the photograph in jpeg format.

The ballot, if required, will open on 2 October 2018 and close at 10:00am Australian Eastern Daylight Time (AEDT) on 22 October 2018.

## **Scrutineer Appointment**
