Scheduled Election

Fair Work (Registered Organisations) Act 2009

Nominations are called for:

Branch Secretary (1)
Branch Assistant Secretary (1)
Branch Councillors (21)

Nominations, which must be in writing and comply with the registered rules of the Federation, may be made at any time from 20 August 2018.

Nomination forms are available on request from my office or the office of the Federation.

Completed nominations must reach the Returning Officer via the lodgement method(s) stipulated below **not later than 12:00pm (AEST) on 10 September 2018**.

PLEASE NOTE:

1. Emails to the AEC inbox that appear to be spam may be blocked. It is the responsibility of senders to ensure that their email reaches the AEC before the deadline for nominations.
2. In order to be able to be received by the AEC, emails (including attachments) should be no greater than 6 MB in size.

Candidate Eligibility Requirements

Candidates must at time of nomination be a member of the NSW Branch and a continuously financial member of the Federation for at least 2 years if nominating for Branch Secretary or Branch Assistant Secretary and a period of one year if nominating for Branch Councillor

Withdrawing Nominations

Nominations cannot be withdrawn after 12:00pm (AEST) on 10 September 2018.

Candidate Statements

Candidates may submit a statement not exceeding 200 words and passport sized photograph for inclusion with ballot material. ***The statement should be provided in word format and the photograph in jpeg format.***

Only statements which comply with the Federation's rules and are received by the Returning Officer **by not later than 12:00pm (AEST) on 17 September 2018** can be accepted.

Voting Period

The ballot, if required will open on 8 October 2018 and close at 10:00am (AEST) on 29 October 2018.

Scrutineers

A candidate may appoint a financial member of the Federation to represent them in the counting of the ballot. A form is available from the Returning Officer for the purposes of appointing Scrutineers
