Nominations, which must be in writing and comply with the registered rules of The Association of Professional Engineers, Scientists and Managers, Australia, may be made at any time from Wednesday 14 November 2018.

Prospective candidates and nominators should verify their financial status and any other qualifications required by The Association of Professional Engineers, Scientists and Managers, Australia's rules prior to lodging nominations.

Withdrawing Nominations

Nominations cannot be withdrawn after 12pm AEDT on Wednesday 28 November 2018.

Candidate Statements

Candidates may submit a statement to be included with ballot material. Only statements which comply with the Rules and are received by the Returning Officer by 12pm AEDT on Wednesday 28 November 2018 can be accepted.

Candidates may provide a short statement limited to 100 words to be distributed with the ballot material. Branch Rule 14.1.5

Voting Period

The ballot, if required, will open on Tuesday 11 December 2018 and close at 10am AEDT on Tuesday 8 January 2019.

Scrutineers

The appointment of scrutineers opens Wednesday 14 November 2018 and closes 9:30am AEDT on Tuesday 8 January 2019.

A form is available from the Returning Officer for the purposes of appointing Scrutineers.
