NOTE: Rule 52AA (7) (c) of the Federation's rules requires a candidate for a position of Branch Executive Member in the preceding 12 months have attended at least four branch meetings of the state organisation "Western Australian Police Union of Workers", where the person was a member of that state association throughout the period;

Rule 52AA (7) (d) of the Federation's rules requires a candidate for a position of Branch Executive Member shall be stationed in the Region from which they nominate at the time of their nomination.

**Voting Period**

The ballot, if required, will open on 05/09/2018 and close at 10:00 am (AWST) on 04/10/2018.

**Scrutineers**

Each candidate nominated for election may, by written notice given to the Returning Officer, not less than seven days prior to the close of the ballot, appoint a member of the Branch to be a scrutineer in respect of that election, being a member other than a candidate, and may by notice in like manner appoint another such member to carry out the functions of scrutineer where the first mentioned does not carry out those functions.
