Lodging Nominations

Scrutineer Appointment

As per the registered rules of the Union, candidates are entitled to appoint a Scrutineer who may be present at all stages of the ballot. The appointment of scrutineers closes at 12pm (Local Time) on 30 November 2018. A Scrutineer Appointment form is available from the Returning Officer.
