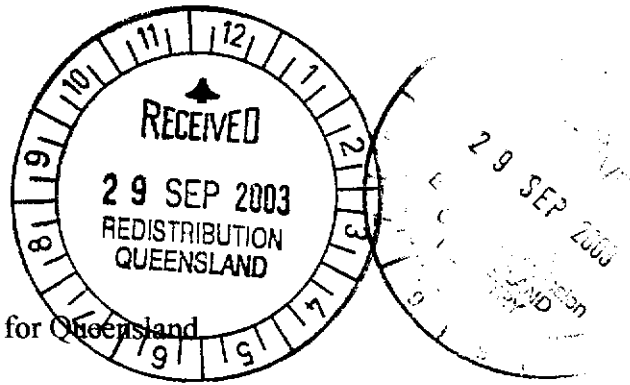

“Proposed Alteration to the boundaries of the Moreton Electorate.”

My wife and I strongly object to the new boundaries which EXCLUDE that portion of Yeronga bounded by Fairfield Road, Hyde Road, Ortive Street and the Brisbane River.

Our objections are as follows:-

- 1 There has been practically complete lack of advice of the proposed changes to the local residents.

There was a notice in the Courier Mail but the print was so small, it was only readable with the aid of a magnifying glass. (Only 1 in 10 households would purchase the Courier Mail.) \* The Southern News, a free local paper has not published any information on the proposed electoral change. Has this publication been advised of the changes?

Residents should have been advised by letter of the proposed changes

2. At present all of the suburb of Yeronga is in Post Code 4104. Changes in the electoral boundaries could cause confusion. e.g. Insurance Policies.
3. Yeronga Services Club. The vast majority of members of the Yeronga Services Club live in Moreton Electorate. Yet the club which has always been in Moreton will end up in Griffith.
4. Any change would cause mammoth confusion at the polling booths on polling day.
5. At present the member for Griffith has his office in Wynnum approximately 20 Km. from West Yeronga. The current member for Moreton has his office at Moorooka approx. 3 Km. away. This would cause great difficulty and possibly impossible for residents of this suburb to visit their elected Member of Parliament.
6. It would be very difficult for the Member for Griffith to adequately service an electorate which includes Wynnum and Yeronga and all parts in between. The residents of Yeronga would be completely forgotten.


7. Many residents including ourselves, have a sentimental attachment to Moreton having lived in the electorate for over 40 years.



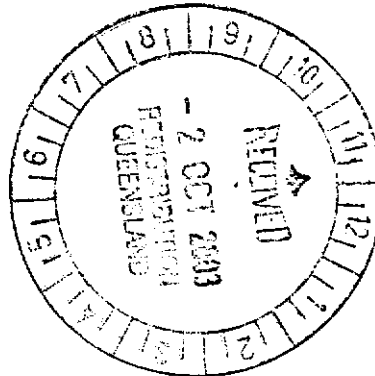
