



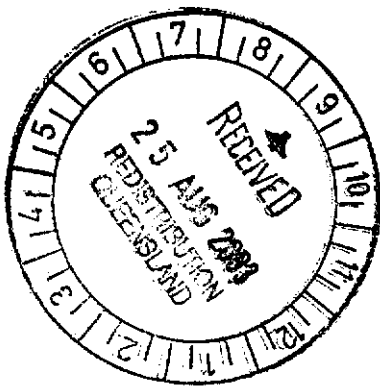

Our Federal State prints it's own Citizenship Certificate; it's own currency; operates it's own State Bank of Australia; issues it's own passports; passes it's own Legislation.

Our First single chamber Parliament has elected members for 10 years commencing on or about 27th March 2001 which reduces to 4 years.

God's State (Federal State) ISSA co-exists with State and Commonwealth Parliaments under authority of High Court of Australia case Law.

In Federal Commissioner of Taxation v Official Liquidator of E.O. Farley Ltd (1940) 63 CLR 278 at 312, per Dixon J:

"It is a consequence of our federal system that, "two governments of the Crown are established within the same territory, neither superior to the other".

God's State (Federal State) ISSA authority is provided by section 5 Colonial Laws Validity Act 1865 (UK) declares that "every representative legislature shall...have...full power to make laws respecting the constitutional powers and procedures of such legislature".

"[T]he opinion of the Parliament to what in a particular, cannot be impugned in a court of law as being an invalid exercise of Parliament's power (1984) 54 CLR 571.

In Halsbury's Laws of England (4th ed) Vol 8, para 811 it is said:

"The courts recognise no limits to Parliaments legislative power, and will not seriously entertain any attack on the validity of a public or private Act".

Re: Police case "Misrepresentation". Osborne's Concise Law Dictionary 3rd ed p 219 defines it as follows:

"A representation that is untrue; a statement or conduct which conveys a false or wrong impression. A false or fraudulent misrepresentation is one made with knowledge of its falsehood and intended to deceive".

[D.J. Harris 3ed Cases and Materials on International Law pp.80-85-125]

"The single function of a Sovereign State, as understood in International Law is, the power of contracting obligations with other States.

The State as a person of International Law should possess the following qualifications:

1. a permanent population
2. a defined territory
3. a government
4. a capacity to enter into relations with other States

A State may exist without being formally recognised, and if it does exist in fact, whether or not it has been formally recognised by other States, it has a right to be treated as a State".

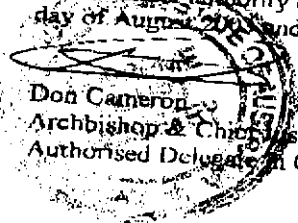
