## Dear Commissioners

I seek to object to the proposed boundaries released by the AEC's NSW Redistribution Committee on the 30<sup>th</sup> of June.

As the representative of over 80,000 electors in north-western NSW, I am appalled that the Committee has recommended the abolition of the seat of Gwydir.

With four scats well under quota in the south and west of Sydney, the boundaries proposed by the National and Liberal Parties provide a logical arrangement that takes into account electorate size, demographic change and communities of interest.

There is simply no need to abolish a country seat in this redistribution.

The abolition of Blaxland, as recommended by the Coalition parties, enables the reduction of one seat in NSW without creating a massive, disparate constituency that is extremely difficult to service.

The seat of Parkes, as proposed by the AEC's NSW Redistribution Committee will be the largest Federal seat in the history of Federal representation in the state of New South Wales.

As a Member of Parliament representing a large country seat, I passionately believe that all communities, however small, deserve equitable access to the Federal Parliamentary Representative.

Only three seats in the current Federal Parliament are traditionally rural in their composition, without major urban components. They are the seats of O'Connor in Western Australia, Maranoa in Queensland and Gwydir in New South Wales. All three seats lack a major and dominant population centre and are comprised of a large number of medium and small sized country towns and communities.

Providing equitable representation in Gwydir is extremely challenging, but possible. A mayor of a medium-sized town in my electorate commented to me recently that I have visited his community, on average, four times a year. This is indicative of the serviceability of a seat like Gwydir. While it is challenging, the residents of this electorate do have access to their Federal Representative. If the size of the electorate were to double, it is logical to assume that such a town would see their Federal Representative only twice a year. If their Federal Representative becomes a Cabinet Minister, the number of visits could be reduced further.

In a city electorate, providing equitable access is relatively easy, due to the small distances between the MP's office and the constituents they represent.

Providing such representation in seats the size of the proposed Parkes will be impossible.

It is true that there are precedents for seats of this size. But massive seats in Western Australia (Kalgoorlie), South Australia (Grey), the Northern Territory (Lingiari) and Queensland (Kennedy and Maranoa) are unavoidable given the size of the states relative to their population base.

New South Wales is much smaller than these states and territories and remains Australia's most populous State. It is therefore tenable to configure 49 House of Representative seats that are manageable in size without resorting to an arrangement of boundaries that seriously disenfranchises so many communities in country NSW.

Gwydir is a Federation seat, an increasingly rare link to our nation's first Federally constituted Parliament. Gwydir currently comprises a diverse group of communities who make an enormous contribution to the economic and social well being of our great nation.

I implore the AEC's NSW Redistribution Committee to revisit the original submission made by The Nationals in relation to country boundary arrangements.

However, if it is the view of the Redistribution Committee that it is necessary to abolish one seat west of the Great Dividing Range, there are alternatives to what is currently being proposed.

The boundaries of Gwydir have undergone dramatic change over recent decades.

As previously stated, Gwydir lacks a major population centre around which it can be anchored. I do not believe that this is an unresolvable problem. However, if it is the desire of the Redistribution Commission to place at least one major centre in each country seat, it is worth noting that previous boundary arrangements for the seat of Gwydir have used Dubbo as a major media and service centre for the communities to its north.

I believe that such a boundary arrangement could be revisited.

While maintaining the proposed boundary between Farrer and Parkes, it is possible to transfer Orange and the surrounding communities of Cabonne, Cowra and Blayney into Parkes, while transferring Dubbo and Narromine into Gwydir.

This would return the city of Dubbo to Gwydir and provide this important Federation seat with a more structured and permanent base.

Under such boundary arrangements, it is likely it would be necessary to excise the southern portions of the Wellington and Mid Western Regional Councils for inclusion in Parkes, along with the northern portion of the Bathurst Regional Council, which is being split under the current proposal from the Commissioners.

Such a boundary could follow Lake Burrendong, the Meroo River and Lake Windamere.

Under such arrangements, Parkes would be centred on Orange in its south east, wedging out to include much of north-western NSW. Orange acts as a service and media centre for many of the Shires that could be included in the re-arranged Parkes, notably Weddin, Parkes, Forbes, Lachlan and Cowra. It is from this region that the Federal seat's enrolment growth shall occur.

Such a proposal would ensure that the diverse nature of north-western NSW was adequately reflected, with the Shires of Gwydir, Moree Plaines, Walgett, Narrabri, Coonamble, Gunnedah, Warrumbungle, Narromine, Dubbo, Wellington (part) and Mid Western Regional (part) united in the Federal seat of Gwydir.

To demonstrate how such arrangements could meet the criteria of this redistribution, I include the following tables.

Again, I re-state my position that it is unnecessary to pursue such a course of action.

As demonstrated in the proposals from the National and Liberal Parties, it is possible to reduce the total number of Federal seats in NSW from 50 to 49 without abolishing a country seat.

I strongly believe that it is preferable to abolish a metropolitan seat, in the interests of maintaining equity in access between country and city voters. The notion of 'one vote, one value' becomes absurd when a voter in NSW resides in a seat 8,550 times greater than the seat of Sydney.

I trust the AEC's NSW Redistribution Committee will carefully consider ways of reducing the size of non-metropolitan seats as part of this important process.
