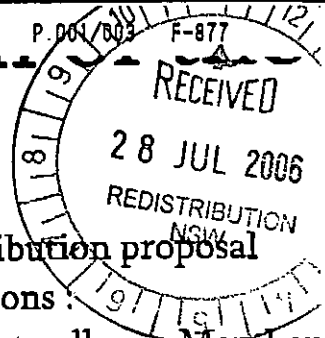

2. The loss of Gwydir, a Federation seat, would reduce the number of country representatives in the Federal Parliament, thereby diminishing the political voice of regional Australians.

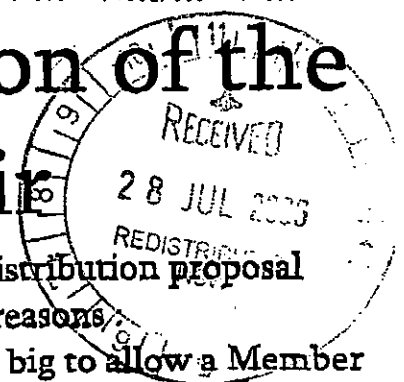

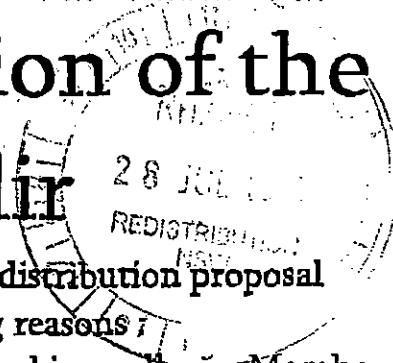
