We, the undersigned, wish to record our strong opposition to the AEC redistribution proposal that would abolish the federal seat of Gwydir. We do so for the following reasons:

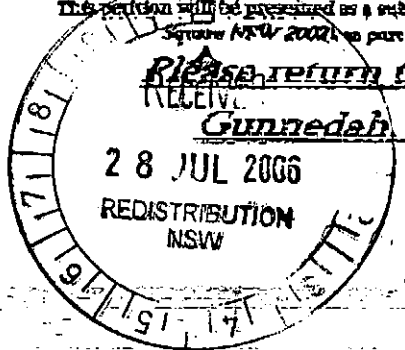
