

If Queensland needs another seat, why take it from us. Surely if they can't reorganise their boundaries (as we in N.S.W. are expected to)

Looking at a map and population figures gives no idea of the size and problems these people have, isolation, distance between various areas, amenities, emergency needs, and the list goes on. They are Australian citizens and have every right to expect what other taxpayers take for granted in their electorate.
