At 47% of the total area of NSW, the proposed new seat would be too big to allow a Member to equitably and fairly service his or her constituents, and/or serve in a Ministerial position.

2. The loss of Gwydir, a Federation seat, would reduce the number of country representatives in the Federal Parliament, thereby diminishing the political voice of regional Australians.
