GWYDIR AND PARKES ELECTORATES ---

I wish to place on record my submission objecting to your Commissioner's decision of the draft redistribution for the Gwydir and Parkes Electorates. In these electorates a case study by voters has clearly justified that your decisions will not work because of the large areas being joined together to form one sitting member of this entire area. In making my decision to put pen to paper my reasons are as follows:

- 1. The draft redistribution of these two electorates is definitely against the country voter who simply needs a good working member close by, and a manageable distance to travel to work with his/her sitting member. Why impose on the country voter these penalties which they would be if the AEC draft redistribution falls into place. No one in their right mind could possibly think that an electorate as large as Tasmania could run in an efficient manner with one sitting member in Parliament for this large electorate. It appears to me that the Commissioner of the AEC has not fully read and understood the ramifications of this draft redistribution otherwise Gwydir and Parkes Electorates would not be faced with this dilemma.
