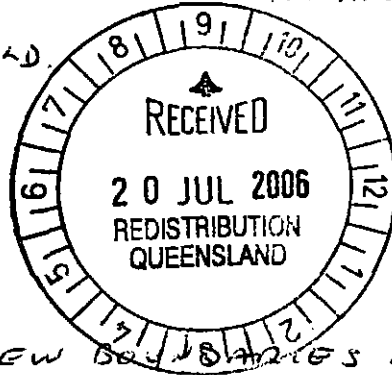

DEAR MEMBERS,

WHILE THE NEW BOUNDARIES MAY BE ON

POPULATION FIGURES AND NO DOUBT IN ACCORDANCE WITH REQUIREMENTS OF THE COMMONWEALTH ELECTORAL ACT OF 1918

I HAVE CONCERNS WITH THE CHANGES OF BOUNDARIES AND THE PROPOSED NAME CHANGE OF THE PROPOSED ELECTORATE.
