To Whom It May Concern,

Please find attached a petition which accompanies this submission.

I am President of the above association which is the equivalent of Neighbourhood Watch but covers a rural area. This Rural Watch was established in 1992 and since the inception I held the office of secretary until in 2005 I became president. Each month I write a newsletter which is delivered to approximately 176 residences. We have an average attendance of 35 people. I have resided in this beautiful part of Australia for 40 years and have always been involved in my community be it the school of which I am a Life Member of the P&C, church, Progress Association of which I am also secretary, rural watch and am also secretary of the Northern NSW Federation of Justice of the Peace Maitland Branch since 1999 so I am trusted by my neighbours to take on their cause.

In my experience with people generally, I have found that they do not like to write letters etc. but to have others take on their grievances on their behalf. Hence, the petition which I hope you will consider. All the names on the petition are people who reside in our area or who own farmland and carry on a farming enterprise. On this, you have my solemn word.

I, along with 95% of the residents of Millers Forest, Duckenfield and Berry Park are appalled with the proposed electoral boundary changes. Firstly, we live in a rural area with farming enterprises diverse as dairy, beef, chicken, horses and turf being practised. As an area surrounded by the farming areas of Morpeth, Wallalong, Pheonix Park, Paterson and Maitland we have nothing at all in common with the seat of Newcastle which is metropolitan.

People from this area shop locally in Raymond Terrace, Maitland, Rutherford and Thornton for their personal and farm supplies. Being well known to the rural supply merchants in the area is important to us as they know our needs for our particular farming enterprise. There is NO common link to Newcastle.

I was a candidate for the last local government elections and whilst doing some PR work prior to these elections, I was amazed that people did not know the electoral boundaries whether for local government, state or federal. People are totally confused. I had people come to me furious that they were not informed of the boundary changes for the last federal elections before they attended a polling booth. They then had to try and decide who to vote for as they did not know their preferred candidate.

Being on the outskirts of an urban seat, do you really think the candidates are really going to care about approximately 500 votes? I have spoken with an electoral officer from the East Maitland office who informed me that the changes are advertised in the media. Well, I'm here to tell you that when you live 9km's from a newsagent there is not a delivery service as such as it is not viable for the newsagent to do a delivery which means an 18km round trip for a measly 20cents a delivery. Nor do we jump in our car to drive to purchase a daily newspaper, most especially in these bleak economic times.

The proposed subdivision of Chisholm will not be an impact on the next elections anyway as there is very little infrastructure in place and this will not happen overnight.

All government bodies are conveniently located in either Maitland or Raymond Terrace and the school feeds into Maitland or Raymond Terrace also. Still no connection with Newcastle.

Keeping all politics out of this, I therefore urge you to please take into account the concerns raised and please do not allow our residents to be pushed into a situation which they feel will not give them the representation they deserve.

We are a tight knit community who care for each other no matter what happens. We, as a community, own and maintain a community hall which was purchased by the Progress Association in 1905.

It is a shame that there is a portion of the locality presently in the Newcastle electorate which in the opinion of the locals should be re allocated to the Paterson electorate as the remainder of the area should also remain.

Please carefully consider our request. There would be locals available to converse with over this matter if you would so wish.
