Reason for registration

Registration as a significant third party will only be approved if the application complies with 287K(2) of the Electoral Act and the Electoral Commissioner is satisfied that the significant third party meets the requirements for registration under section 287F of the Electoral Act. Otherwise, the Commissioner must refuse the application.

A person or entity is required to register as a significant third party in a financial year if one of the following applies: (*Tick one*)

- L electoral expenditure exceeds \$250,000 during the current financial year or any one of the previous three financial years; or
- L electoral expenditure is at least equal to the disclosure threshold during that financial year and electoral expenditure during the previous financial year was at least one-third of the revenue of the person or entity for that year; or
- during that financial year the person or entity operates for the dominant purpose of fundraising amounts:
 - the aggregate of which is at least equal to the disclosure threshold; and
 - that are for the purpose of incurring electoral expenditure or that are to be gifted to another person or entity for the purpose of incurring electoral expenditure.
