- This return is to be completed with reference to the Financial Disclosure Guide for Third Parties incurring Political Expenditure.
- Amounts should be reported on a GST inclusive basis.



Where a person or organisation incurred more than \$12 800 for one or more of the five categories of political expenditure (listed below) in the 2014-15 financial year, the person or organisation must disclose the amount of political expenditure incurred for each category.

For **each category** of political expenditure, record the total amount incurred on goods and services provided during the financial year, even if payment for these goods and services was made outside of the financial year.

Expenditure for purposes other than these categories is not political expenditure as defined by the *Commonwealth Electoral Act 1918* (the Act) and does not need to be reported.

# \*What do sections 328, 328A and 328B do?

Services Act 1992\*\*.

Section 328 of the Act requires all electoral advertisements to include the name and address of the person who authorised the advertisement and, except in the case of newspapers, the name and place of business of the printer at the end.

Section 328A imposes a similar requirement on electoral advertisements on the internet.

Section 328B imposes a similar requirement in relation to how-to-vote cards.

Electoral advertisements must be authorised at all times, not just during an election period.

### \*\*What does subclause 4(2) of Schedule 2 to the Broadcasting Services Act 1992 do?

This requires the identification of those who have requested that political matter be broadcast. Guidelines at www.acma.gov.au are relevant.

This applies at all times, not just during an election period.

## Part 2: Gifts received for political expenditure for financial year 1 July 2014 to 30 June 2015

Details of **gifts** of more than \$12 800 **received and used** (wholly or partly) to incur political expenditure disclosed in Part 1 of this return. Part 2 of this return applies to a third party:

- who is required to complete Part 1 of this return; and
- received a gift of more than \$12 800 (whether within the 2014–15 financial year or not); and
- used that gift, or part of it, to incur the political expenditure reported in Part 1; or reimburse such expenditure.

Where the above criteria is met, the following details must be disclosed:

- full name and address details\*\*\* of each person or organisation from whom the gift was received
- · date each gift was received
- value or amount of each gift.

Any gift which has been disclosed in a previous financial year does not need to be disclosed again.
