

Significant Third Party Disclosure Return

FINANCIAL YEAR 2021-22

Section 314AB(1) of the Commonwealth Electoral Act 1918 (Electoral Act) requires significant third parties to lodge a return within 16 weeks after the end of the financial year.

The due date for lodging this return is 20 October 2022.

Section 314AB(3A) of the Electoral Act requires significant third parties who are registered during the 2022-23 financial year to lodge a 2021-22 return within 30 days of registration.

- This return is to be completed by the person who is nominated as the financial controller with the AEC.
- This return is to be completed with reference to the Financial Disclosure Guide for Significant Third Parties.
- Amounts should be reported on a GST inclusive basis.
- This return will be available for public inspection from 1 February 2023 at www.aec.gov.au.
- Any supporting documentation included with this return may be treated as part of a public disclosure and displayed on the AEC website.
- The information on this return is collected under s 314AB of the Electoral Act.
