To whom it may concern,

ACT Labor welcomes this opportunity to provide suggestions on the boundaries for the proposed new divisions of the ACT.

This submission will make a series of recommendations for the consideration of the Redistribution Committee regarding the placement of boundaries for the new electorates.

This submission relies on the population projections released by the Redistribution Committee and the guidelines for submissions. All proposed divisions meet the population criteria for current and projected enrolments.

This submission will also make recommendations on appropriate names for the new electorates.

ACT Labor has a clear position that, as far as reasonably possible, the new divisions should encompass complete suburban boundaries. We do not believe that creating divisions that split suburbs across multiple electorates is in the best interest of representative democracy.

It is our view that the three new divisions should be drawn in such a way so that there is a northern division, a central division and a southern division with borders running east-west as far as possible. We do not endorse divisions that are drawn in a so-called "y shape" as we do not believe that these would create divisions that combine communities of interest.

We look forward to seeing the outcomes of the redistribution process.

Division Names

Fenner

We propose that the northern-most ACT division be named Fenner as it will incorporate only electors who were enrolled in the old division of Fenner.

Canberra

We propose that the southern-most ACT division be name Canberra as it will incorporate only electors who were enrolled in the old division of Canberra.

Central Division (Molonglo)

We recommend that the new division receive an appropriate Aboriginal name. We ask that the Redistribution Committee seek the input of the ACT Aboriginal and Torres Strait Islander community when determining the name for the new division.

One possible suggestion for an appropriate name for the new central division could be Molonglo, recognising the central axis the course of the Molonglo River corridor (including Lake Burley Griffin) would provide to the proposed division.

The name would reflect both the Indigenous language relationship with the district, and the role of the river in anchoring the early settlements that would ultimately form the heart of the national capital and seat of federal parliament.



Division Boundaries

We propose that the boundaries for each new division be comprised of the following:

Fenner

We propose that the division of Fenner encompass the northern regions of the ACT, following the northern NSW/ACT border and taking in all of the suburbs that comprise the district of Gungahlin and the majority of the suburbs that comprise the district of Belconnen except for the suburbs of Page, Hawker, Weetangera, Macquarie, Cook, Aranda, Bruce and Kaleen (see Map 1).

Central Division (Molonglo)

We propose that the Central division encompass the suburbs the constitute the inner north and inner south suburbs of Canberra, the southern belt of Belconnen suburbs from Kaleen to Hawker, and the northern-most suburbs of Woden Valley namely, Curtin, Lyons, Hughes, Phillip and Garran. We envisage that this electorate would also encompass the eastern-most regions of the ACT to the NSW border including Beard, Oaks Estate, Majura

Whilst we have included Belconnen District 1 in this division, it is our view that any development to the north of this district should be incorporated into the division of Fenner.

Canberra

We propose that the boundary for the southern division of Canberra encompass the former division of Namadqi which included all suburbs in the district of Tuggeranong, the southern Woden Valley suburbs of Chifley, Farrer, Isaacs, Mawson, Pearce and Torrens, and the remainder of the ACT south and west of the Murrumbidgee River. In addition, the division should also include the Woden Valley suburb of O'Malley and the Eastern areas of the ACT bounded by Hindmarsh Drive, Canberra Avenue and the ACT/NSW border.

We also propose that this division encompass the districts of Weston Creek and Molonglo which includes the district of Stromlo, down to the Brindabellas and Rendezvous Creek (see Map 3).

We believe that the divisions we have presented provide for proper community representation, acknowledge the growth of the ACT and allow for flexibility in the face of future population growth.


