We have always been and identify with the Federal Boothby electorate since we moved to this area in 1988. We have lived in Flagstaff Hill for 30 years and our community identifies and recognizes more with the Adelaide Plains and Mitcham Hills areas which encompass of the areas of Marion and Blackwood.
