The Parramatta Office has received 2 applications for enrolment as a prisoner. Both are currently enrolled (one with a TA notation and one with the JF/JS notations). Both have provided the prison address as the place they wish to be enrolled.

As per GEM, they are not eligible for prisoner enrolment as they are currently enrolled. We can add the prison's details as their postal address but do we also have to reject the application?

Also, one has requested option 1 at question 7. Does this mean he is simply asking for a postal vote without becoming a GPV?

Prisoner enrolment queries

Hi Ian as discussed, the enrolment forms can be used to update the elector's postal address to the prison address. Q1 is option A and Q5 is their current enrolled address.

Check that the TA was added due to prisoner processing and for no other reason, update if required.

In regard to selecting option 1 for a postal vote application, include this (PVA application) with the acknowledgement letter that is sent to the elector.

For your further information, regardless of the prisoner's length of sentence, if a PVA is received, ballot papers will be sent and the determination to accept or reject will be made at Dec scrutiny.

While prisoners with a JF notation are excluded from certified lists, there has been no change to stop an elector with a JF notation from applying for a postal vote, if we were to do this it would be considered as if we were conducting preliminary scrutiny and that is not allowed on PVAs.
