Number of voters with incorrect other marks – smudge, blemish, scribble, dots or print bleed through	82

Number of voters where error clock not marked by polling official	6
Number of voters where error clock mark was missed during scanning	6
Number of voters where possible match with a non-voter	34
Number of voters with more than 1 mark	195
Number of voters with more than 2 marks	0

Note: 22 multi-voters were not loaded into the Multi-mark database due to there being no physical mark against the elector.
