Phil - just one overall comment.

There is a difference between multiple marks investigations, and multiple voting. At this stage I would caution against saying multiple voter, as that is what we are trying to establish with the assistance of the AFP.

It is indeed a normal part of our processes to examine "alleged multiple voters" based on material suggesting we have "multiple marks" on a certified list, or "multiple declaration votes" submitted, but it only becomes a "multiple-voter" once that has been established with a reasonable degree of certainty (even if it may never have the evidentiary requirements to succeed as a prosecution before a court).

So, we just need to be cautious I think with our language so that we are precise with what we are doing. Hope this makes sense.

Good evening,

Today I met Tom briefly this morning at this request, and then worked with Kellie to prepare some media contingency speaking points should the m-v activity become the course of a media inquiry. I ran the proposed lines verbally with Tom and Tess, and he gave me some feedback which I have incorporated.

Media management going forward

In addition to this Thomas called me this evening. We discussed media management of m-v, and how media could raise it at the declaration for Herbert if they are aware by/before then.

Whether the m-v matters are in the public space before then, or even arise on the morning of the declaration, or not at all, there is obviously a need to be prepared.

Our discussion was that I go up to Townsville for the declaration to manage this risk (contingent or realised by then) in the media-space.

At the minimum my role it might be merely managing the logistics of the media's attendance in and out of the event to allow Ann to have a clear run on presiding over her declaration event. The media then might interview the candidates and leave.

However, if the m-v story has broken over the weekend or even on the day, I would cover this off by being available for media after the completion of the declaration, and therefore separate Ann's declaration event, and her, from the m-v investigation and all the speculative implications that follow.
