

FOI REQUEST LS5826

Request for:

1. All documents that document suspected incidences of multiple voting (which includes suspected multiple 'marking off' at the polling place) at the 2016 Federal Election, including but not limited to documents setting out the number of incidences of suspected multiple voting and the polling locations where those incidences occurred.
2. All documents setting out a tally of the number of instances of potential multiple votes in the 2016 Federal Election, including but not limited to documents that state the number of instances per polling place and/or per electorate.
3. That portion of the briefing documents taken by Mr Rogers to the Finance and Public Administration Legislation Committee on 18 October 2016 that refers or relates to the multiple voting issue.
4. Any document setting out a tally or total number of suspected multiple voting at the 2013 Federal Election, including but not limited to details of the number of instances per polling place and/or per electorate.
5. The list that sets out the electorate details of those people who were written to by the AEC in relation to suspected multiple voting. [N.B. This relates to the statement by Mr Rogers to the Senate that "For 2013, we sent out about 18,000 letters for multiple voting", and the list that would have been created to allow those letters to be sent out.]
6. Any memoranda or correspondence to or from Mr Tom Rogers and/or Mr Pablo Carpay regarding or relating to multiple voting at the 2016 Federal Election, dated on or after 2 July 2016.
