## Request for:

The completed premises inspection for the polling place at Randwick Town Hall in the Division of Wentworth, NSW which was carried out as part of the Electronic Premises Inspection Tool (EPIT) project ahead of the 2016 federal election;

Any documents, reports, notes or correspondence relating to the decision of the Electoral Commissioner to appoint Randwick Town Hall a polling place under s80 of the Commonwealth Electoral Act 1918 (Cth) for the 2016 federal election;

Documents about the compliant and non-compliant accessibility aspects of the polling place at Randwick Town Hall which was displayed on the AEC's website during the election period;

Documents about complaints made regarding the accessibility of the polling place at Randwick Town Hall:

- by [REDACTED] either shortly before or in the week after the 2016 Federal election (most probably made sometime between 26 June-7July); and
- recording of the number and dates of any other complaints made about the accessibility of the polling place at Randwick Town Hall at the last 2010, 2013 and 2016 federal elections.
