SUGGESTIONS FOR THE PROPOSED REDISTRIBUTION OF COMMONWEALTH ELECTORAL DIVISIONS IN THE STATE OF VICTORIA 2020

OVERVIEW

Please accept my suggestions for the 2020 redistribution of Victorian electoral divisions. Population growth in Victoria has recently been extremely rapid and this reflected in Victoria being entitled to a second additional electorate within three years.

The population growth has largely occurred in the outer suburbs of Melbourne. The challenge is how this will be accommodated alongside the sagging enrolments of some electoral divisions in Western Victoria, and in some divisions Eastern and South Eastern Melbourne divisions. In addition, much of this rapid growth is concentrated in a small number of areas.

I have been a follower of the redistribution process for some time and I have observed that even with the addition of new electorates, the approach to redistribution has been overly incremental. This may be acceptable when numbers of electors are relatively stable but it does seem to have led to a number of divisions without a strong community of interest or ending up as 'bits and pieces seats' that are made up of what is left over, or boundaries that cut through a community of interest such as major shopping centres being divided over two or even three divisions.

This has motivated me to making this submission - I believe that there is a time when an incremental approach is no longer sustainable and a slightly more radical outlook is required to achieve optimal outcomes for the redistribution process.

ENROLMENT PROJECTIONS

The enrolment projections provided by the AEC have been adopted for this submission. Overall, the aim has been to try to be as close to the mid-point in the 2025 forecast period though this cannot always be achieved. The task has been made more challenging by concentrations of growth in areas such as Cranbourne, Craigieburn and the Wyndham area.

The enrolment projections for 2020 and 2025 have been provided in the summary for each division.

BOUNDARY DETERMINATION

In developing boundaries for electoral divisions, a range of criteria have been used:

- Readily identifiable natural features such as the Yarra River or the Victorian Alps.
- Major infrastructure that can provide a legible boundary main roads, freeways, railway lines.
- Community of Interest trying to combine likeminded communities by local government area, transport routes, or in regional areas, linking the rural hinterland with major regional centres.
- Definition of metropolitan and regional divisions the aim has been to maintain divisions outside Melbourne as distinctively regional rather than creeping into the peri-urban fringe.
- ABS SA2 boundaries wherever possible though some SA2 areas have been split along SA1 boundaries. Wherever possible these have been drawn on recognizable and legible boundaries – main roads.

The aim, wherever possible, has been to keep suburbs and their focal points in one division. If a boundary is required, the preference has been to split minor centres rather than major centres.

POLITICAL OUTCOMES

Political outcomes and how the proposed boundaries may affect the interest of any political party has not been a determining factor in this submission.

SUMMARY

Victoria is entitled to a 39th electoral division in the Commonwealth House of Representatives. The addition of the extra division will require some degree of change.

The summary of the proposed changes are:

- Provision of two new electoral divisions to reflect rapid population growth in Victoria
- The first would be to the west of Melbourne and including Melton, Bacchus Marsh, and the Calder Corridor from Gisborne to Malmsbury.
- The second new division would be in the South Eastern suburbs and be based on the Narre Warren and Berwick areas.
- Abolition of Hotham to facilitate the new eastern division. Hotham is one of a number of eastern and south eastern suburbs divisions that have had sagging enrolments. Abolition of Hotham would allow an improvement in community of interest in neighbouring divisions – for example, it is proposed that Chisholm be largely contiguous with the City of Monash.
- Indi and Gippsland are the only two divisions proposed to be unchanged.
- Reinstitution of the Yarra River as a divisional boundary. It is proposed that Menzies be moved wholly south of the river.
- Major changes to enrolment in Deakin and Chisholm due abolition of Hotham and changes to Menzies. In each case fewer than 50% of electors will be within their previous division, however, there are tangible improvements in community of interest.
- Substantial changes to Cooper and JagaJaga. JagaJaga to be more focused on the Shire of Nillumbik and Cooper to become an east –west division rather than north-south.
- Major changes to McEwen to accommodate population growth. The changes are so great that it may be worth considering renaming the division.
- Significant changes to western suburbs divisions to facilitate the new division and population growth.
- Regularisation of the Macnamara / Higgins boundary to remove the Caulfield 'tail.
- Corangamite to be a Geelong suburban and Bellarine Peninsula division only.
- Echuca to be transferred from Nicholls to Mallee.
- Ballarat and Bendigo to lose areas closer to Melbourne and gain rural hinterland.

Details of changes to all divisions are outlined further in this document.

NAMING OF ELECTORATES

This submission does not make the effort of allocating names to the new divisions. The naming of electorates can at times become a major distraction to the process. For the purpose of this exercise, they are referred to as New Electorate East and New Electorate West.

Some points in division naming to be made:

- An electorate should be named 'Hawke', after the former Prime Minister Bob Hawke, who has died since the last redistribution.
- Chisholm is preferred to be maintained as a division name over Hotham, even though the proposed boundaries for Chisholm would have more voters than Hotham. The memory and efforts of Caroline Chisholm, a pioneering Australian social worker, seem more deserving of ongoing recognition than those of Sir Charles Hotham, a 19th century Victorian Governor of seemingly no great renown.
- Consideration may be provided to renaming Corangamite now that it is seemingly a Greater Geelong division and has no physical connection with the lake of the same name. I am aware and am usually supportive of the preference for Federation electorate names to be preserved but the link has become overly tenuous.
- The Division of McEwen is proposed to be substantially changed to the point of being almost unrecognizable. Based on the proposal for Mallee in this submission, consideration may be given to changing the name of Mallee to McEwen. This would recognise the link between Sir John McEwen and Northern Victoria, and remove the geographical name 'Mallee' from a division which has long expanded beyond what is recognized as the Mallee Region. If Echuca should be incorporated into Mallee, the change of name would also recognize Sir John McEwen as an MP for the former Division of Echuca.

PROPOSED CHANGES TO VICTORIAN ELECTORAL DIVISIONS

This section outlines proposed changes to each electoral division and provides an indicative map for some divisions to illustrate the extent of the proposed boundaries.

ASTON



It is proposed that there be minor changes to the Division of Aston. These are required to manage changes in surrounding divisions.

On the 2025 projections it is forecast that there would be 114,766 electors on the new boundaries. This is at the lower end of the allowable range.


The proposed changes are that the SA2 of Lysterfield be transferred to La Trobe and that the suburb of Upper Ferntree Gully be transferred to La Trobe also.

Some electors from the Bayswater North SA2 would be transferred to Aston. This would be the area south of Canterbury Road and west of Liverpool Road.

BALLARAT



The proposed boundaries for Ballarat are a reset that it will make it regional division based on the City of Ballarat rather than having a substantial component of electors in the Outer Melbourne commuter belt. The current boundaries include Bacchus Marsh which is now largely a commuter town with the result that the regional focus of the Ballarat division is being weakened. The long term eastwards move of Ballarat has meant that some Ballarat suburbs are now within Wannon.

It is proposed that the boundaries of Ballarat move north, west and south west from Ballarat to pick up rural areas that have long standing business, work, school and sporting links with Ballarat. The areas proposed to be included in Ballarat include Linton, Beaufort, Avoca and Maryborough.

The proposed changes include:


- Bacchus Marsh and Bacchus Marsh Region, including the town of Ballan would be transferred to the Division of "New Electorate West". Bacchus Marsh is now essentially a commuter town and has strong links and community of interest with Melton to the east. Bacchus Marsh is the primary service centre for the areas surrounding it and which is why these are proposed to be moved also.
- The Daylesford SA2 is proposed to be transferred to "New Electorate West". Daylesford town is linked to both Ballarat and the Central Highlands area. Townships with the SA2 such as Trentham are considered to have stronger links with areas to the east which would be in the same division. There is also a major road linking Bacchus Marsh, Ballan and Daylesford.
- All of the Avoca SA2 would now be unified in Ballarat.

- The town of Maryborough and its surrounds are proposed to be transferred to Ballarat from Mallee. These areas have stronger links with Ballarat than other parts of Mallee. It is noted that Maryborough has been moved through several redistributions but has not been able to be accommodated with Ballarat with which it has the strongest links.
- Beaufort, Smythes Creek and Golden Plains North areas close to Ballarat and within the Ballarat sphere of influence are transferred to Ballarat.

BENDIGO



The proposed boundaries for Bendigo are affected by the need to create a new division in the west / north west of Melbourne.

It is proposed that the boundaries of Bendigo centre more on the city of Bendigo and include more of the city's rural hinterland. Southern parts of the division in the Central Highlands and along the Calder Highway are proposed to be moved to the Division of "New Electorate West".


The proposed changes include:

- Woodend and Kyneton SA2 areas are proposed to be transferred to "New Electorate West". These are Calder Highway communities that are considered to stronger links with areas to the west such as Daylesford and Trentham, and Gisborne and Macedon to the south..
- Those parts of the Heathcote SA2 east of the Campaspe River would be transferred to Nicholls. This would unite communities along the Northern Highway in Nicholls. The community of Axedale would remain in Bendigo.
- Rural areas to the west of Bendigo along the Calder Highway be transferred to the Division of Bendigo. These includes the towns of Dunolly, Inglewood, Wedderburn and Charlton.
- The township of Carisbrook west of Castlemaine transferred to the division from Mallee.

BRUCE



The proposed abolition of Hotham allows for consolidation of Bruce in the Dandenong and Springvale areas.

The projection for the current boundaries is that Bruce would be below the acceptable range in 2025. There would be a need to add extra electors if this major change was not proposed.

It is proposed that Bruce gain electors from Hotham and Isaacs whilst the eastern part of the division would be become part of the "New Electorate East".


The proposed changes are

- The southern part of Hotham would be transferred to Bruce forming a secondary focus around Springvale.
- The remainder of Dandenong not part of Bruce would be transferred from Isaacs.
- Keysborough would be transferred from Isaacs.
- Those parts of the division east of Dandenong Creek Doveton, Endeavour Hills and Hallam would be transferred to "New Electorate East".

CALWELL



The rapid population growth of Northern and Western Melbourne, and the consequent requirement for an additional electoral division impact on the boundaries of Calwell.

It is proposed that Calwell will still be a City of Hume based division. However, it is proposed that there be exchanges of electors between the north and west parts of the local government area.

The proposed changes to Calwell are considered to be substantial.


The proposed changes are

- The majority of the Craigieburn area would be transferred to McEwen.
- Melbourne Airport and those parts of Tullamarine and Keilor west of the Tullamarine Freeway to be transferred to Maribyrnong.
- Sunbury and parts of Bulla would be transferred to Calwell from McEwen.
- Sunbury South including Diggers Rest would be transferred to Calwell from Gorton. This would unite all of the Sunbury area in Calwell.

CASEY




There will need be substantial changes to Casey to accommodate the wider changes in the Eastern and South Eastern suburbs. It is proposed that the Dandenong Ranges area will be transferred to La Trobe whilst the electorate will move westwards and gain electors from Deakin in the Croydon area. The overall focus of the division will on the Outer Eastern Suburbs, Yarra Valley and Yarra Ranges.

CHISHOLM



It is proposed that the Division of Chisholm move southwards to become primarily a City Of Monash based division. This is made possible by the proposed abolition of Hotham. The proposed Chisholm will firmly anchor the division in the City of Monash. All of the City of Monash will be accommodated within the division.

The projection for the current boundaries is that Chisholm would be below the acceptable range in 2025. There would be a need to add extra electors if this major change was not proposed.

On the 2025 projections it is forecast that there would be 118,982 electors on the new boundaries. This is above the mid point of the allowable range.


The proposed changes are

- The northern parts of Chisholm located in the City of Whitehorse would be moved to Deakin.
- Chisholm would expand into the Southern part of the City of Monash. These areas are currently within Hotham.
- Monash City would be incorporated into Chisholm.
- There would be a small transfer to Kooyong.
- There would be a small area of Bruce transferred. This triangular shaped area would be bounded on freeways on two sides and is better linked to Chisholm on the third side.

COOPER



The Division of Cooper is proposed to undergo significant changes. It is proposed that Cooper go from being a North South electorate between the Merri and Darebin Creeks to an East West electorate spanning Darebin Creek. In many ways, the proposed boundaries will be similar to those of Batman (predecessor of Cooper) prior to the 1984 redistribution.

The changes are largely driven by JagaJaga moving North East to focus on the Shire of Nillumbik. It is considered that there is a community of interest between Fairfield and Alphington in Cooper and Ivanhoe in the current JagaJaga.

The Clifton Hill area south of Merri Creek is proposed to be moved out of the division – Merri Creek will form an easily recognizable boundary.

Most of Reservoir is proposed to be moved to Scullin but La Trobe University would remain in Cooper. Cooper would largely follow the #86 tram line.


The proposed changes are :

- Clifton Hill would be transferred to Melbourne.
- Most of Reservoir East, all of Reservoir West and northern parts of Kingsbury SA2 would be transferred to Scullin.
- The southern parts of the City of Banyule Ivanhoe, Heidelberg, Heidelberg West and Rosanna are proposed to be transferred to Cooper.
- The boundaries between Cooper and Jaga in Rosanna are generated by a desire for easily recognition major roads and the railway line.

CORANGAMITE



Corangamite if forecast to have 135,907 electors by 2025 within its current boundaries. This is significantly above the allowable upper limit and it will be necessary to transfer electors. Suburban growth in Geelong and the Surf Coast are the drivers of this growth. The growth of Corangamite will require it to draw into the Greater Geelong area and shed the rural areas to the west.

Currently, Corangamite wraps around Corio on three sides with little community of interest between Golden Plains Shire and the Bellarine Peninsula.

It is proposed that Corangamite be consolidated so that it covers the southern suburbs of Geelong, Torquay and Jan Juc on the Surf Coast, and the Bellarine Peninsula. It will be undoubtedly a second Geelong division. It is proposed that all of the remaining rural areas be transferred out of the division.

The proposed changes include:


- Transfer of Bannockburn, Lethbridge and Meredith from Corangamite to Corio. These areas have strong links with the western suburbs of Geelong and provide for a better community of interest with Corio.
- Minor changes so that all of Highton and Newcomb Moolap will be consolidated in Corio.
- Areas to be transferred to Wannon include the remaining parts of the Colac Otway Shire; Anglesea, Lorne and Winchelsea in Surf Coast Shire; More rural areas of the Golden Plains Shire

• Belmont is proposed to be transferred to Corangamite so that it is joined with the adjacent suburbs of Grovedale and Waurn Ponds.

CORIO



DEAKIN



It is proposed that the Division of Deakin move westwards to become primarily a City Of Whitehorse based division. This is made possible by the proposed move of Chisholm southwards. HOTHAM

MALLEE

Mallee is the largest electoral division by area in Victoria and over many years has been affected by population loss in rural areas and smaller towns. As a result, it has become more geographically disparate with the eastern and south eastern parts of the division now incorporating areas such as Maryborough that have stronger community relationships outside of the division than within.

It is proposed that southern parts of the division be transferred to the electorates of Bendigo and Ballarat. To compensate for these losses, it is proposed that Echuca and its surrounds be incorporated into Mallee. This would:


- Focus Mallee on being a Murray River division linked by the Murray Valley Highway and issues such as water and irrigation. In this way, it would mirror Farrer across the Murray in New South Wales.
- Provide Mallee with a third strong population 'pole' along with Mildura and Horsham. This would provide greater community focus and identification.

The proposed changes include:

- The SA2s of Echuca, Lockington Gunbower and Rochester be transferred to Mallee from Nicholls.
- Stawell and the surrounding area would be transferred from Wannon and strengthening links with Horsham.
- All of the Avoca SA2 would be transferred and unified in Ballarat.
- The town of Maryborough and its surrounds are proposed to be transferred to Ballarat from Mallee. These areas have stronger links with Ballarat than other parts of Mallee. It is noted that Maryborough has been moved through several redistributions but has not been able to be accommodated with Ballarat with which it has the strongest links.
- Rural areas to the west of Bendigo along the Calder Highway be transferred to the Division of Bendigo. These includes the towns of Dunolly, Inglewood, Wedderburn and Charlton.
- The township of Carisbrook west of Castlemaine transferred to Bendigo.

MARIBYRNONG



The creation of a new electoral division to the west of Melbourne will have significant knock on effects for divisions in the region.

Proposed changes to Maribyrnong are geographically significant but retain almost 80% of electors within the division.


It is proposed that the Maribyrnong River will form the western boundary of Maribyrnong. It would become a North Western suburbs division following Mount Alexander Road and the Calder and Tullamarine Freeways from Flemington to Keilor and Melbourne Airport.

The proposed changes are:

- Suburbs to the west of the Maribyrnong River Footscray, Braybrook and the suburn of Maribyrnong would be transferred to Fraser.
- Kensington would be transferred into Maribyrnong from Melbourne.
- The SA2 of Keilor would be united in the division with transfers from Fraser and Calwell.
- Tullamarine and Melbourne Airport would be transferred from Calwell.
- Minor transfers of voters from Wills in areas west of the Tullamarine Freeway.

McEWEN



The existing Division of McEwen is forecast to undergo extraordinarily rapid growth and would significantly outside the allowable range in 2025 if the current boundaries were to remain. The challenge is how to accommodate this growth when it is so concentrated in Craigieburn and areas to the North.

The proposed changes to McEwen are substantial and would significantly alter the character of the division. What was previously a mix of outer suburbia, rural / urban fringe and rural areas would become very much a suburban division focused on the outer northern suburbs of Melbourne, particularly these northern parts of the Cities of Hume and Whittlesea..

The proposed changes are

- Those parts of McEwen in the Shire of Nillumbik Doreen, Yarrambat, Hurstbridge, St Andrews and Strathewen be transferred from McEwen to JagaJaga.
- Kilmore, Broadford, Wandong and Lancefield would be transferred to Nicholls.
- In the west, communities such as Gisborne, Macedon, Riddells Creek and Romsey would be transferred to "New Electorate West".
- Sunbury and parts of Bulla would be transferred to Calwell.
- Outer northern suburban parts Scullin such as Epping, South Morang (North) and Wollert would be transferred to McEwen.
- The majority of the Craigieburn area would be transferred to McEwen.

Only minor changes are proposed to the Division of Melbourne.



MENZIES



It is proposed that the Division of Menzies be located entirely south of the Yarra River as it was prior to the 2018 redistribution. The projection for the current boundaries is that Menzies would be below the acceptable range in 2025. The need to add extra electors and the move south of the river will require major changes to the division.


On the 2025 projections it is forecast that there would be 116,766 electors on the new boundaries. This is marginally below the mid point of the allowable range.

The proposed changes are :

- All areas north of the Yarra River are transferred to JagaJaga.
- Menzies remains as a Manningham focused division but needs to move eastwards into Ringwood, Ringwood North and Croydon West to achieve quota.
- In these expansion areas the Ringwood Bypass will become the southern boundary and the Maroondah Highway the eastern boundary of the division.
- Moving eastwards was seen as having a greater community of interest than remaining with a cross river crossing or expanding south of the Eastern Freeway.


On the 2025 projections it is forecast that there would be 125,734 electors on the existing boundaries. Electors will need to be transferred as this is above the allowable range. As the Division of Gippsland to remain unchanged, all of these electors will need to be transferred from western parts of the division. These changes would make Monash a more regionally focused division rather than overlapping the Outer Melbourne boundary.

The proposed changes are that the SA2 of Koo Wee Rup be largely transferred to Flinders with some voters being transferred to Holt. The proposed area to be transferred to Flinders was part of that division prior to the 2018 redistribution.

The SA2 of Bunyip – Garfield is proposed to be split. The eastern area around Bunyip to remain in Monash due to community links with Drouin. Garfield and Tynong would be transferred to La Trobe.

NEW ELECTORATE EAST




It is proposed to create a new division in the Outer South East of Melbourne to replace Hotham which is proposed to be abolished. Existing electorates to the south and east of the proposed new electorate are all forecast to have higher than allowable enrolments in 2025. A new division in the south-east is considered to be preferable to continuing the continued glacial shift south eastwards of divisions such as Bruce, Hotham and Chisholm. It also allows for better defined communities to be linked together.

The new division is proposed to be located in the Narre Warren and Berwick areas. It would draw electors from Bruce, Holt and La Trobe. The forecast enrolment of 117,964 is marginally above the mid range.

NEW ELECTORATE WEST



Rapid and sustained population growth to the west and north of Melbourne has driven the requirement for Victoria to have a 39th electoral division. Therefore, it is logical that the new electorate be located in this area. The provision of a new division also allows for communities of interest to be linked in a single division.

The proposed "New Electorate West" is located to the west and north west of Melbourne. It has two major population and social focal points – the Melton / Bacchus Marsh area to be located in the south, and the Macedon Ranges / Calder Corridor / Central Highlands area in the north. The areas were linked previously in the former Division of Burke.

The new electorate would draw electors from:

- Ballarat
- Bendigo
- Gorton
- McEwen.

Melton and Bacchus Marsh are closely linked as communities for work, school and sporting activities. What were once rural towns are very much part of the Outer Melbourne commuter belt and more focused toward Melbourne.

In the north, the proposed "New Electorate West" links Calder Corridor communities such as Gisborne, Macedon, Woodend, Kyneton and Malmsbury. These are all within the Macedon Ranges Shire and were previously split across divisions.

The Daylesford SA2 is proposed to be transferred to "New Electorate West" from Ballarat. Daylesford town is linked to both Ballarat and the Central Highlands area. Townships within the SA2 such as Trentham are considered to have stronger links with areas to the east which would now be in the same division. There is also a major road linking Bacchus Marsh, Ballan and Daylesford.

The proposed changes to the boundaries of Nicholls would see it be a north – south division linked by the Goulburn Valley Highway from near Melbourne through to the Murray River. Shepparton would remain the population centre of the electorate.

SCULLIN

The Division of Scullin is proposed to undergo significant changes. It is proposed that Scullin become a more compact inner urban division that basically follows the outer end of the South Morang train line.

WANNON



The existing Wannon covers South Western Victoria from the South Australian border to Colac and includes outer suburbs of Ballarat.

It is proposed that the boundaries of Wannon move west from Ballarat but also eastwards to the edge of Geelong. The Victorian coast from Anglesea west to the South Australian border would be within Wannon. In response to the forecast growth of Corangamite, most of the remaining rural areas in that division would be transferred to Wannon.

Overall, the boundaries of Wannon will move south out of Central Victoria and east toward Geelong. Communities will be linked east – west by the Princes, Hamilton and Glenelg Highways.

The proposed changes include:

- Beaufort, Smythes Creek and Golden Plains North areas close to Ballarat and within the Ballarat sphere of influence are transferred to Ballarat.
- The Avoca SA2 is transferred to Ballarat.
- The SA2 of Stawell (with the exception of the township of Great Western) are transferred to Mallee. Stawell is close to Horsham and has a substantial relationship with that major centre.
- Areas to be transferred to Wannon from Corangmite include the remaining parts of the Colac – Otway Shire; Anglesea, Lorne and Winchelsea in Surf Coast Shire; More rural areas of the Golden Plains Shire. Areas such as Anglesea and Winchelsea are within the Victorian State electorate of Polwarth so there are political associations with areas to the west.

Only minor changes are proposed to the Division of Wills.
