1 Name

This determination is the *Public Service (Subsection 24(1)—Australian Electoral Commission Non-SES Employees) Amendment Determination 2022/01.*

2 Commencement

This determination commences on the day it is signed.

3 Authority

This determination is made under subsection 24(1) of the *Public Service Act* 1999.

4 Schedules

Each determination that is specified in a Schedule to this determination is amended or repealed as set out in the applicable items in the Schedule concerned, and any other item in a Schedule to this determination has effect according to its terms.

Schedule 1—Amendments

Public Service (Subsection 24(1)—Australian Electoral Commission Non-SES Employees) Determination 2021

1. Section 9

Repeal the section, substitute:

9 Second annual adjustment of salary and allowances

- (1) Employees' salaries are adjusted by 3.00%, with effect from 1 December 2022.
- (2) Each adjustment is to be calculated based on the salary immediately before the adjustment under subsection (1).
- (3) Healthy and Safety Representative Allowance, First Aid Allowance and Multiple Divisional Site Management Payment Allowances are adjusted by the same percentage as salaries, with effect from 1 December 2022.
- (4) Each adjustment of an allowance is to be calculated based on the allowance immediately before the adjustment under subsection (3).
- (5) Schedule 2 has effect.
- (6) This section and Schedule 2 have effect despite section 8 and Schedule 1.

2 Schedule 2

Repeal the Schedule, substitute:

Schedule 2— Second annual adjustment—Salary and allowances from 1 December 2022/01

Note: See section 9.

1 Salary

From 1 December 2022, salary for an employee covered by column 1 of an item of the following table at a pay point described in column 2 of the item is payable at the rate for that pay point (the *new rate*) described in column 3 of the table. This is an adjustment of 3.00% under subsection 9(1) of the Public Service (Subsection 24(1)—Australian Electoral Commission Non-SES Employees) Determination 2021.
